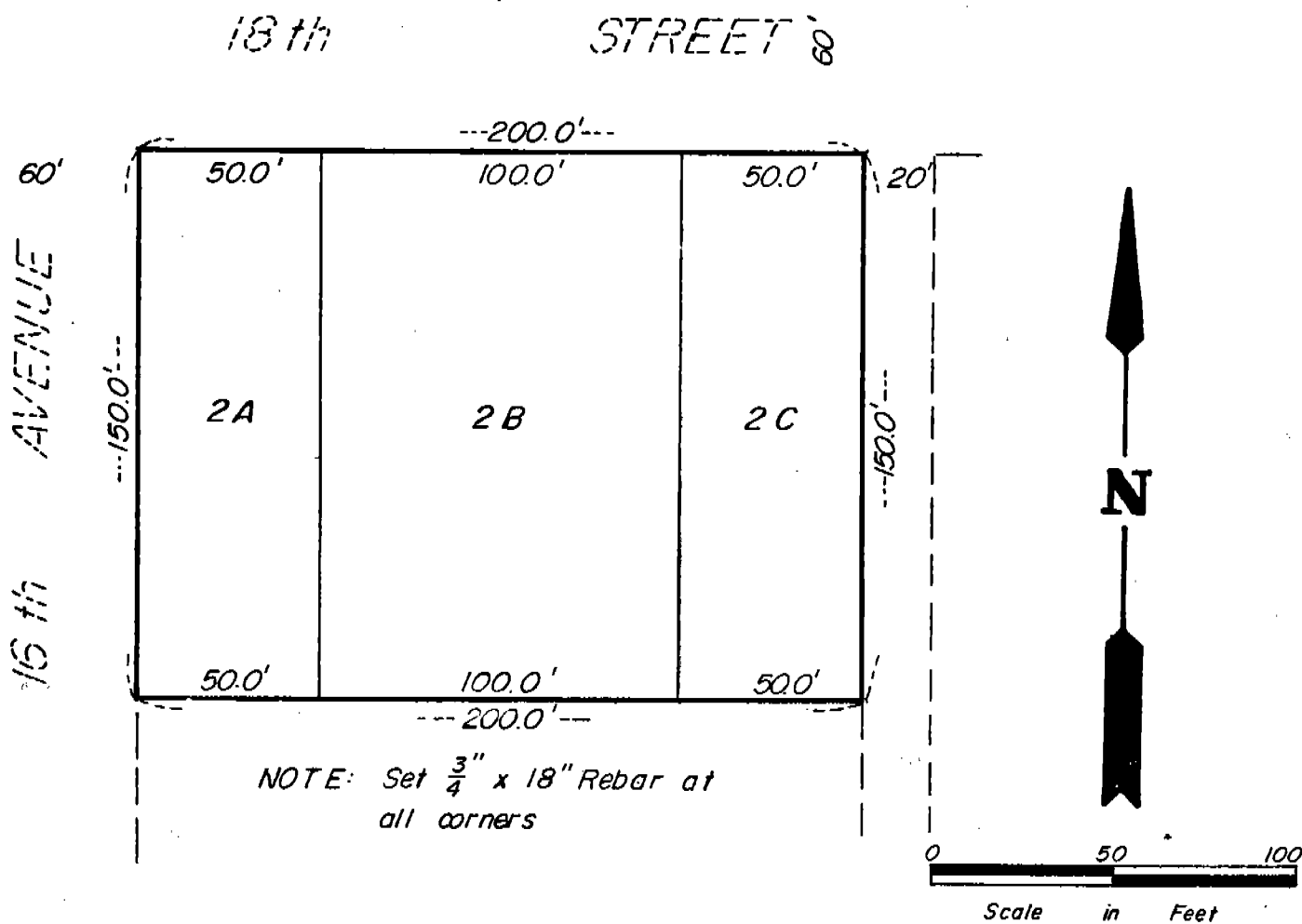


# SUBDIVISION OF LOT 2, BLOCK 5, LOGAN'S ADDITION

### SURVEYOR'S CERTIFICATE

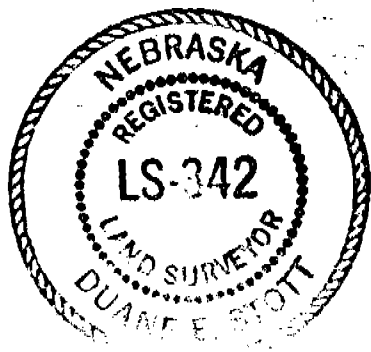

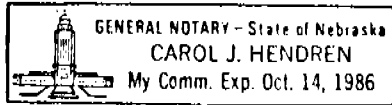

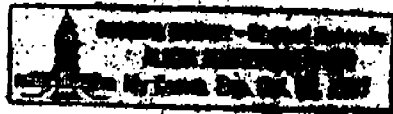
