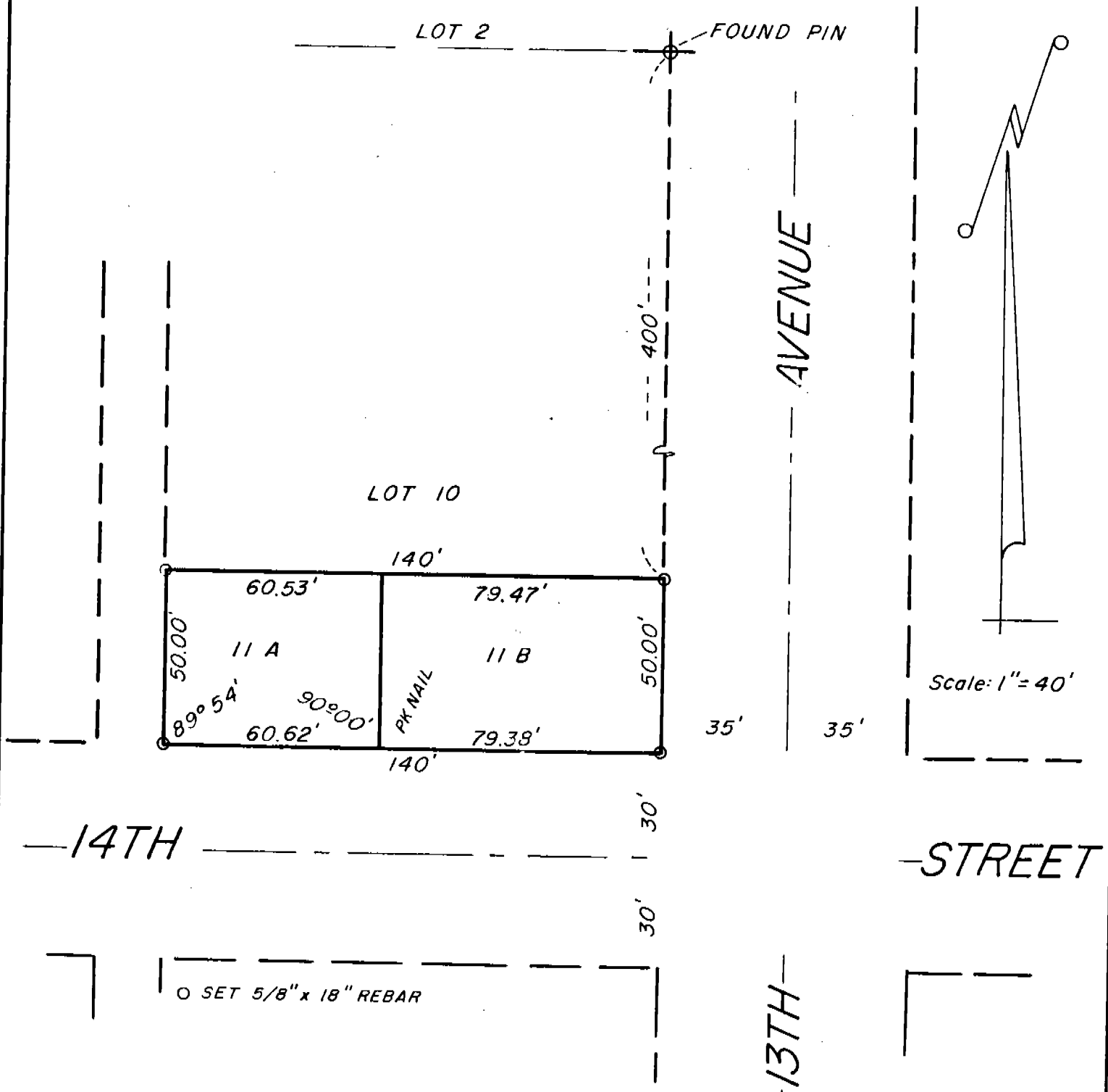


JONES SUBDIVISION OF LOT 11, PARK ADDITION TO THE CITY OF MITCHELL, NEBRASKA



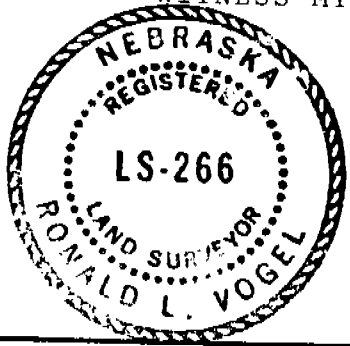

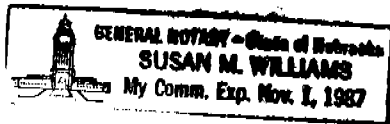
