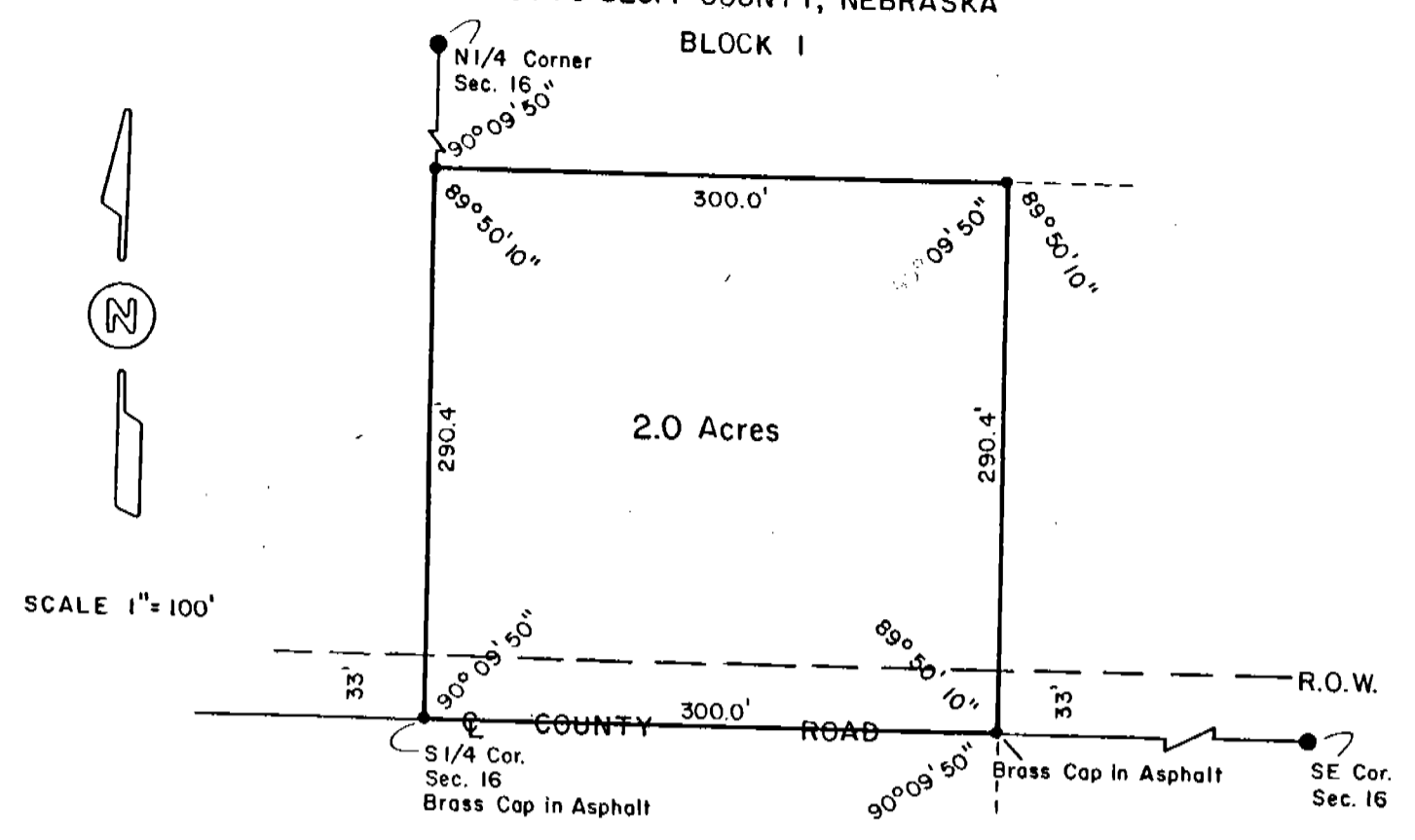

SURVEYOR'S CERTIFICATE

I, Ronald L. Vogel, a competent surveyor of Scotts Bluff County, Nebraska, hereby certify that I have surveyed a part of the Southeast Quarter (SE $\frac{1}{4}$) of Section Sixteen (16), Township Twenty-one (21) North, Range Fifty-five (55) West of the 6th P.M., more particularly described as follows:

Beginning at the Southwest Corner of such Southeast Quarter; then North along the West line of such SE $\frac{1}{4}$ a distance of 290.4 feet; then a deflection angle right 90° 09' 50" a distance of 300.0 feet; then a deflection angle right 89° 50' 10" a distance of 290.4 feet to the South Line of such Section 16; then a deflection angle 90° 09' 50" a distance of 300.0 feet to the Point of Beginning, containing an area of 2.0 acres.

That the accompanying plat is a true delineation of such survey, drawn to a scale of 100 feet to the inch. That all corners are marked with 3/4" x 18" iron rods. All dimensions are in feet and decimals.

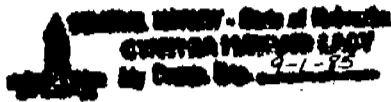
