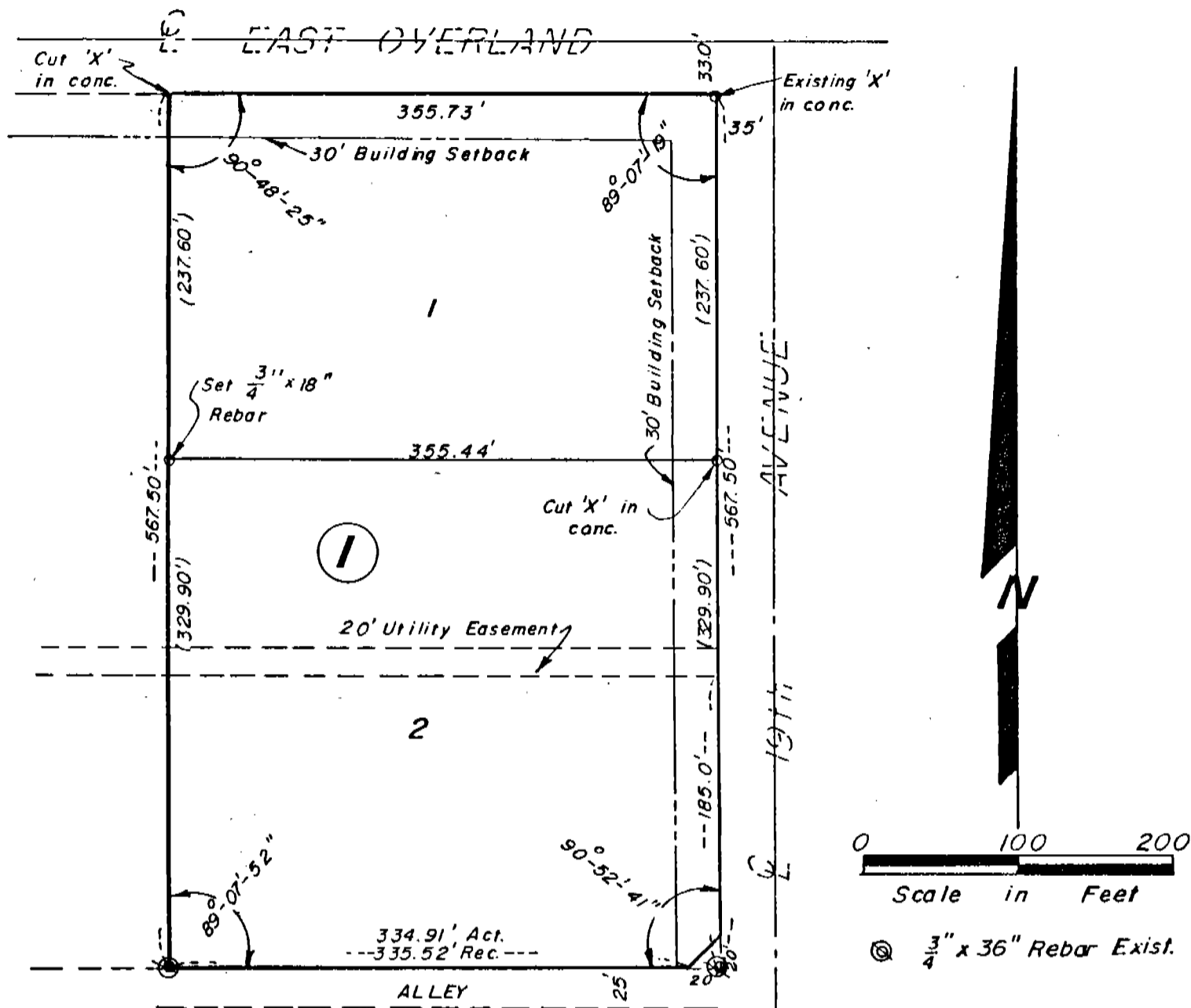


AMENDED PLAT OF LOTS ONE AND TWO, BLOCK ONE, BLAHA SUBDIVISION AND REPLAT

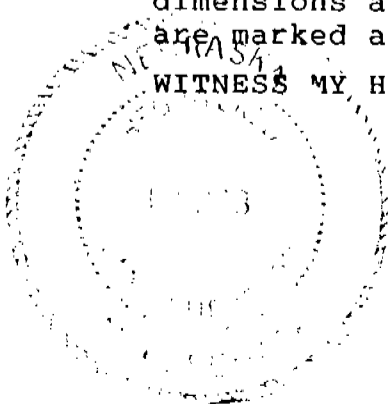

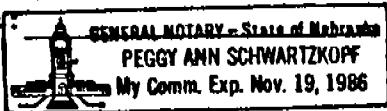
