

SURVEYOR'S CERTIFICATE

I, Duane E. Stott, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Lot 1, Block 1, Braun Subdivision, a subdivision of part of the Southeast Quarter of Section 19, Township 22 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the Southeast corner of Section 19, thence northerly on the East line of the SE½ of Section 19, a distance of 256.90 feet, thence a deflection angle left of 90°-02'-40", a distance of 314.45 feet, thence a deflection angle left of 89°-30'-00", a distance of 256.90 feet to the point of intersection with the South line of the Southeast Quarter of Section 19, thence a deflection angle left of 90°-29'-30", on said South line, a distance of 316.45 feet to the point of beginning, containing an area of 1.86 acres more or less.


