I HEREBY CERTIFY that during the month of September A.D. 1926,
I surveyed Park Place Addition to Lyman, Nebraska, which is situated on a part of the
S¹/₂ S¹/₂ Sec. 34, T. 23 N., R. 58 W. of the 6th P.M., and more particularly described as
follows:

Beginning at the South Quarter corner of Section Thirty-four
(34); Township Twenty-three North (T23 N.); Range Fifty-eight West (R58 W.) of the
Sixth P.M., Scotts Bluff County, Nebraska, and running thence west along the section line,
a distance of 307.62 feet; thence north and parallel with the west line of Fourth Avenue,
961.16 feet; thence east 330 feet; thence south 62 feet; thence east 1166 feet; thence
south 942.1 feet; to the south line of said section and thence west 1189 feet to the
point of beginning.

That the annexed plat is a correct delineation of said survey
drawn to a scale of 50 feet to the inch. 1¹/₂" X 1¹/₂" X 16" pine stakes are driven flush
with the ground surface at the lot corners. The width of all lots, blocks, streets,
avenues and the alley, and the dimensions thereof are indicated on the plat in feet and
decimals. Each lot bears its own number.

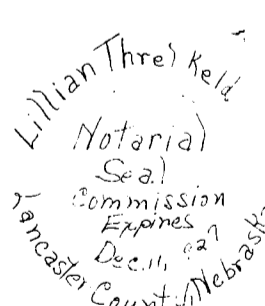
This CERTIFIES that the Security Land Company, a corporation, duly organized

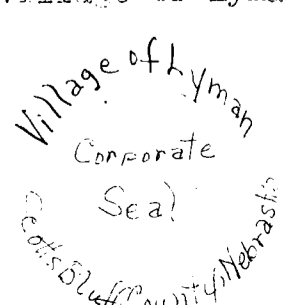

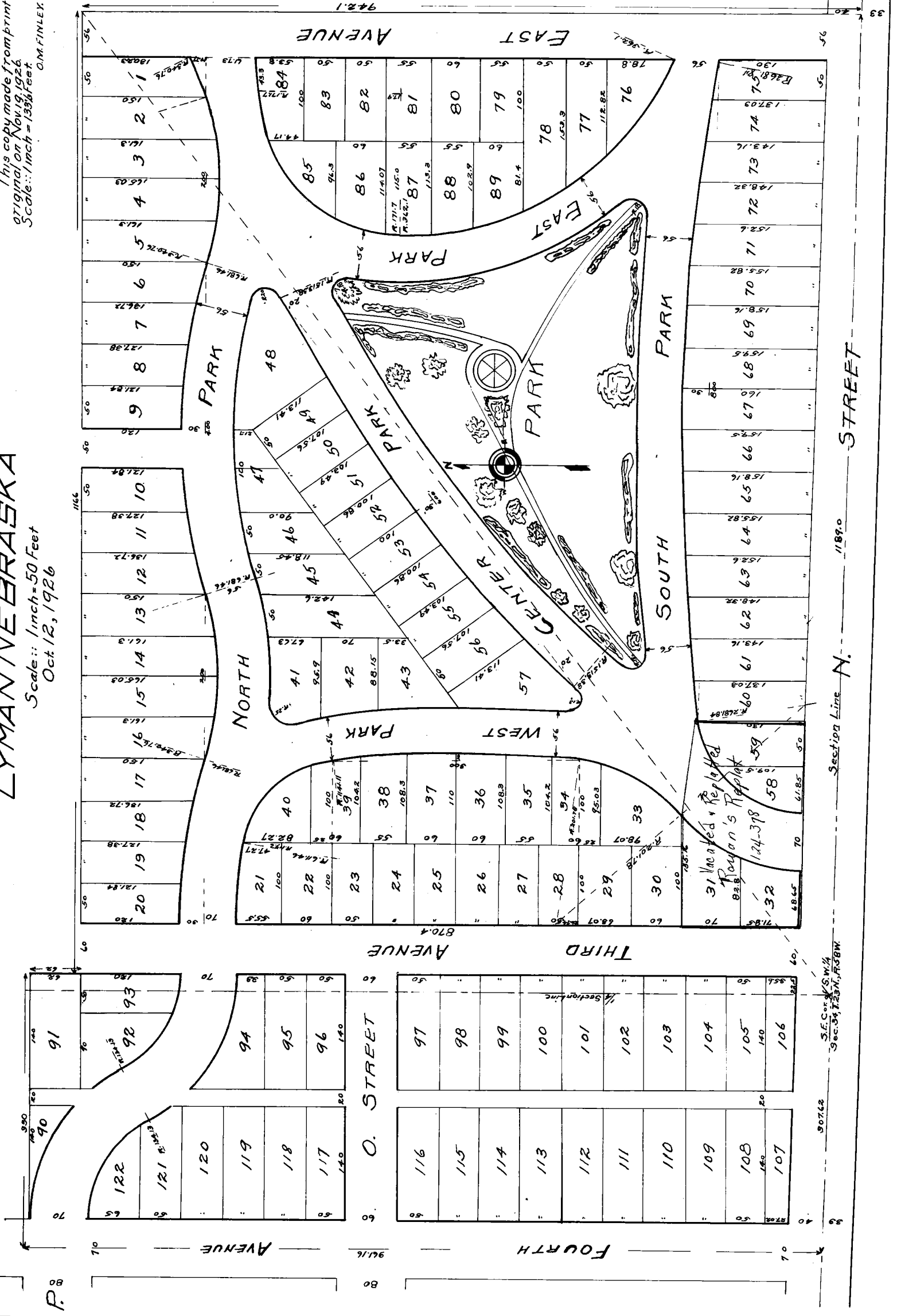
