

I HEREBY CERTIFY, That on the 23d day of August, A.D. 1922 and the 25th day of September, A.D. 1926, I accurately surveyed Imperial First Addition to the City of Scotts-bluff, Nebraska, situated on a part of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Sec. 25, Twp. 22 N. of R. 55 W. of the 6th P.M., Scotts Bluff County, Nebraska, more fully described as follows; Beginning at a point 95.75 feet East and 20 feet South of the N.W. corner of the said S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Sec. 25, thence S $1^{\circ} 03'$ W. a distance of 699.0 feet thence East 704.4 feet, thence North 699.0 feet, thence West 691.5 feet to the point of beginning; that the above Plat is a correct delineation of the said survey drawn to a scale of 100 feet to the inch. 2"x2"x14" fir stakes are driven well into the ground at the front corners of each lot; that the lots, blocks, streets, avenues and alleys are well and accurately staked off and marked and the dimensions thereof indicated on the Plat in feet and decimals, and each lot and block bears its own number.
