

## SURVEYOR'S CERTIFICATE

I, M. C. Schaff, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of GUEST SUBDIVISION, Block 1, a subdivision of part of Tax Lot 7B, located in the Northwest Quarter of Section 3, Township 23 North, Range 58 West of the 6th P. M., in the Town of Henry, Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the Northwest Corner of said Tax Lot 7B, thence East, along the South Right of Way of South Street, a distance of 150.00 feet; thence a deflection angle right of 89 degrees 38 minutes 18 seconds, a distance of 73.0 feet; thence a deflection angle right of 89 degrees 06 minutes 36 seconds, a distance of 150.0 feet to the East Right of Way of Nichols Avenue; thence North, on said East Right of Way, a distance of 75.90 feet to the Point of Beginning.
