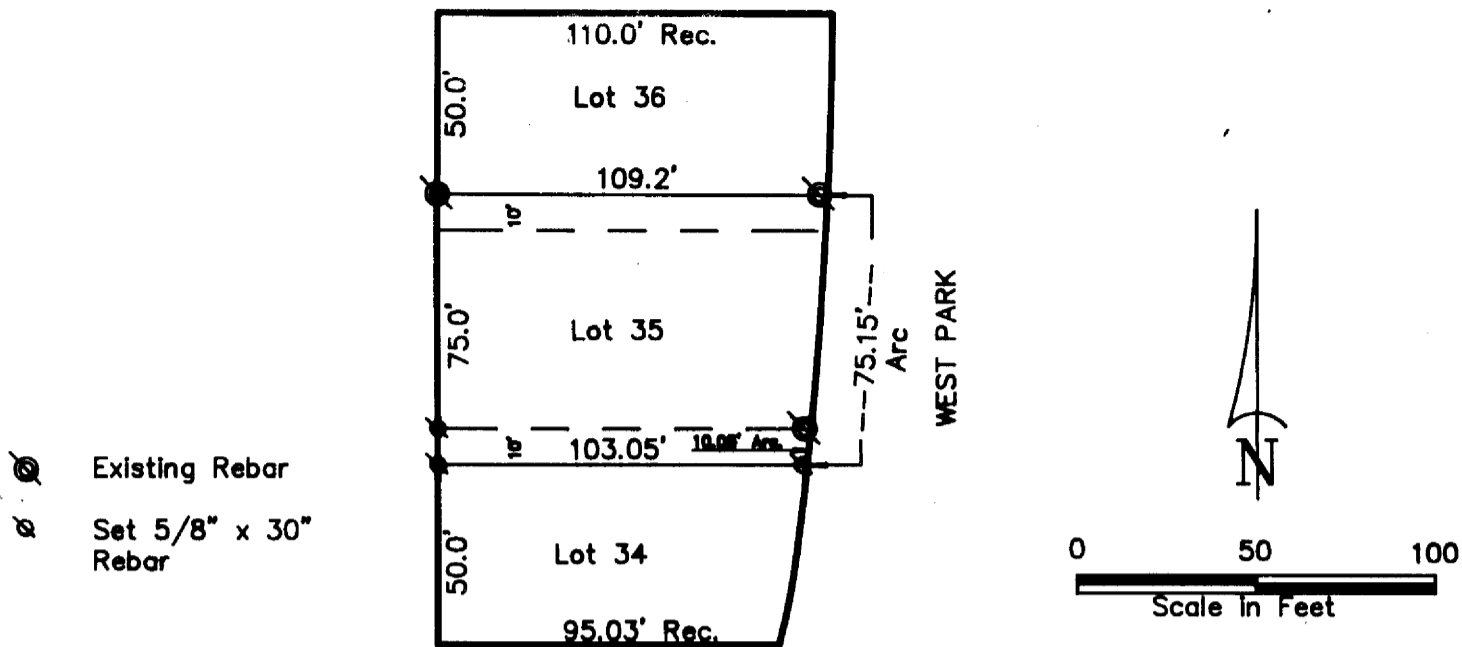

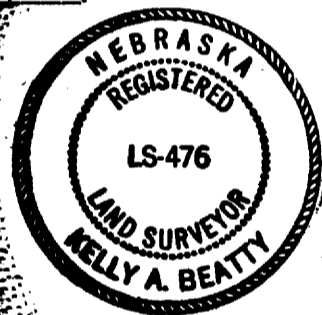
SURVEYOR'S CERTIFICATE

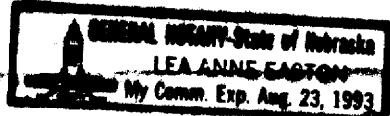

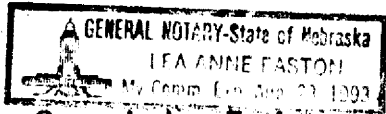

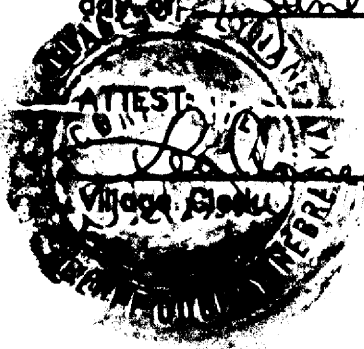
