

SURVEYOR'S CERTIFICATE

REPLAT OF BLOCK 2. BLUE 'J' SUBDIVISION GERING, NEBRASKA

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of REPLAT OF BLOCK 2, BLUE 'J' SUBDIVISION, a subdivision in the City of Gering, Scotts Bluff County, Nebraska, more particularly described as follows:

With reference to the Northwest Corner of the Southeast Quarter of the Southeast Quarter of Section 35, thence southerly on the West line of said Southeast Quarter of the Southeast Quarter, a distance of 795.50 feet; thence a deflection angle left of 90 degrees 00 minutes 00 seconds, a distance of 392.50 feet to the Point of Beginning; said point also being the Northeast Corner of Block 1, Blue 'J' Subdivision as previously recorded; thence a deflection angle left of 85 degrees 41 minutes 10 seconds, a distance of 3.23 feet; thence a deflection angle right of 85 degrees 41 minutes 10 seconds, a distance of 238.00 feet; thence a deflection angle right of 90 degrees 00 minutes 00 seconds, a distance of 632.73 feet to the point of intersection with the arc of a curve having a radius of 4446.75 feet and which is concentric with and 137.0 feet distant northeasterly, measured radially from the centerline of the main track of the North Platte branch of the Union Pacific Railroad Company as now constructed and operated; thence northwesterly on the arc of said curve, a distance of 318.20 feet, having a long chord of 318.19 feet; and a deflection angle right and 123 degrees 32 minutes 28 seconds from the last described course to said long chord; thence a deflection angle left"of 87 degrees 58 minutes 55 seconds, from the extension of said long chord, a distance of 68.88 feet to the point of intersection with the arc of a curve having a radius of 436.59 feet and which is concentric with and 9.5 feet distance northeasterly, measured radially from the centerline of the spur track of said Railroad Company as now constructed and operated; thence northwesterly on the arc of said curve, said curve having a long_chord of 176.81 feet and a deflection angle right of 113 degrees 55 minutes 34 seconds from the last described course to said long chord, a distance of 178.04 feet to the Southwest corner of Block 1, Blue "J" Subdivision, as previously platted; thence a deflection angle right of 78 degrees 25 minutes 24 seconds from the extension of the last described long chord to the Southeast corner of said Block 1, a distance of 190.92 feet; thence a deflection angle left of 43 degrees 38 minutes 32 seconds, a distance of 230.00 feet to the Point of Beginning, containing an area of 3.67 acres, more or less.

That the accompanying plat is a true delineation of said plat drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals and that each lot bears its own letter and number designation. That the boundary of the plat is shown with a heavy solid line with dashed lines being shown for orientation purposes only.
