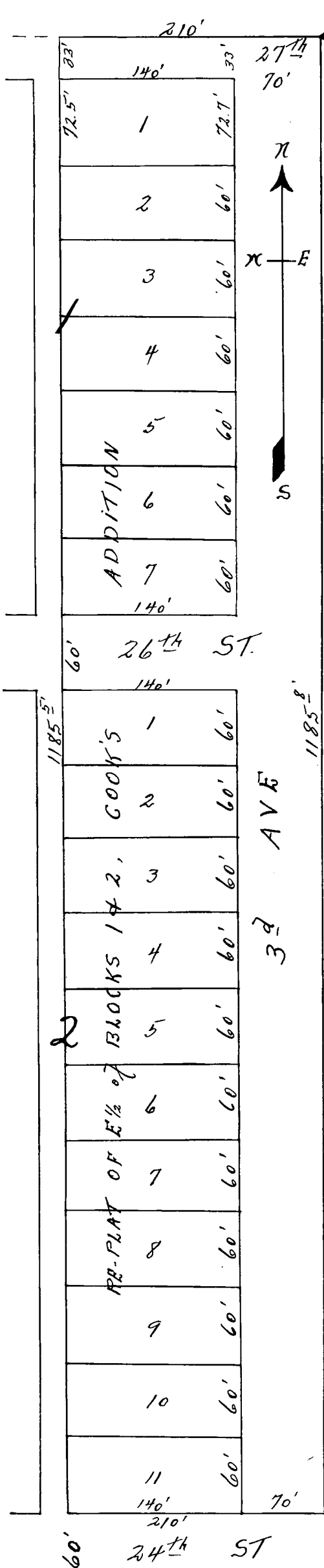

RE-PLAT OF THE EAST HALF OF BLOCKS
1 & 2 OF COOK'S ADDITION
TO
SCOTTSSLUFF, NEBRASKA.

I HEREBY CERTIFY that on the 23d day of April, A.D. 1927, I surveyed the Re-plat of the East Half of Blocks 1 & 2 of Cook's Addition to Scottsbluff, Nebraska, situated on a part of the North East Quarter of Section 23, Twp. 22 N. of R 55 W. of the 6th P.M., more fully described as follows; Beginning at a point on the North line of said section 23, which is 678.95 feet West of the North East corner of said section 23, thence South a distance of 1185.8 feet, thence West a distance of 210 feet on the North line of 24th Street, thence North a distance of 1185.5 feet on a line parallel with the center line of Broadway, thence East on the North line of said section 23 for a distance of 210 feet to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 100 feet to an inch. 2"x2"x14" oak stakes are driven well into the ground at the front corners of each lot. The widths of the streets and the dimensions of the lots are indicated on the plat in feet and decimals. Each lot and block bears its own number.

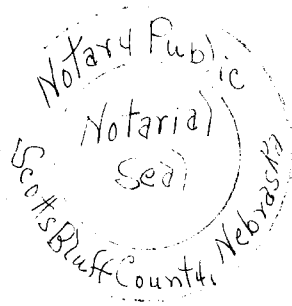
