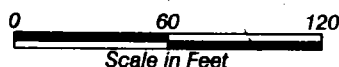
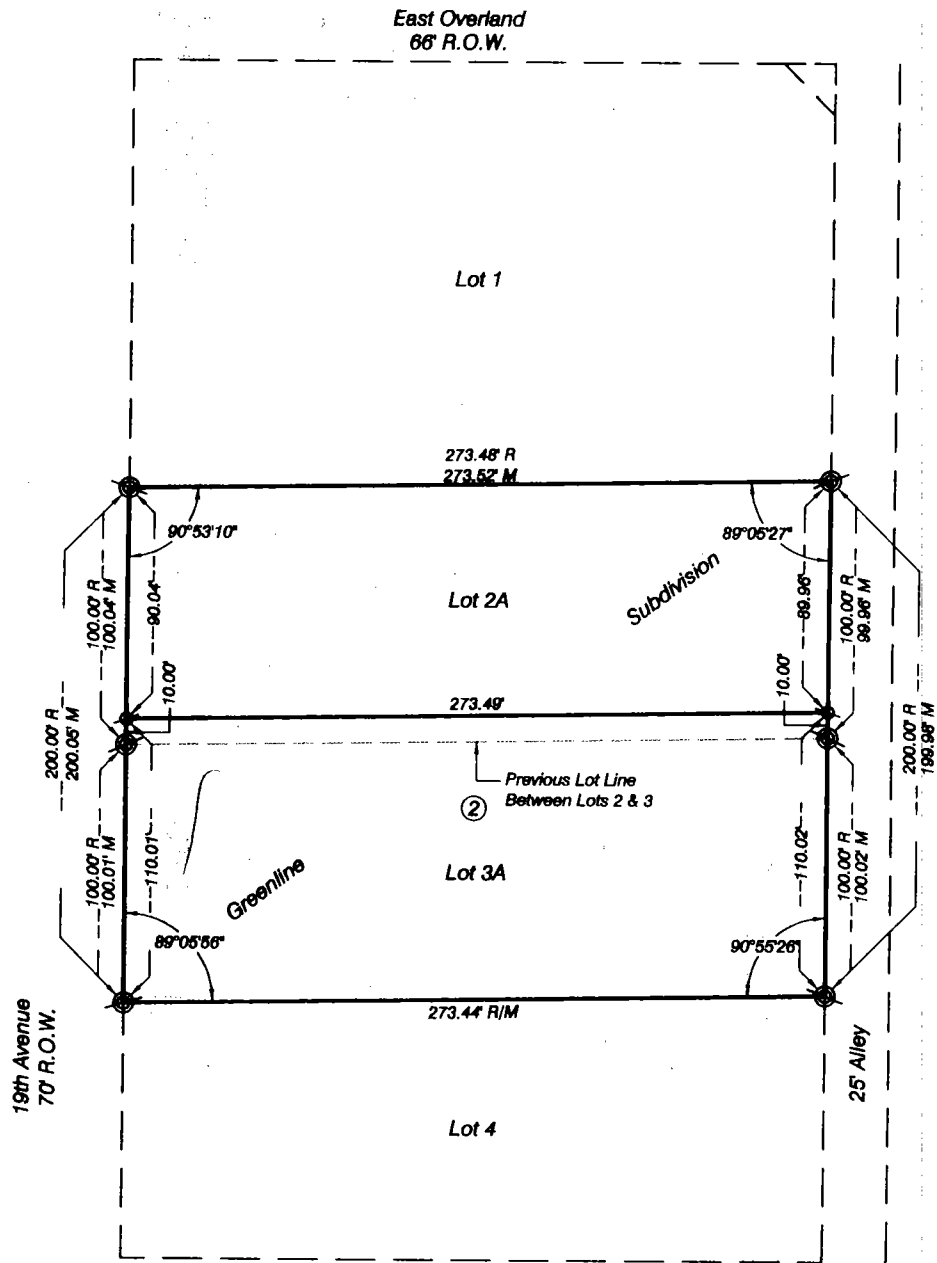

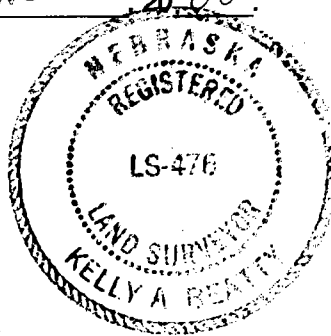
SURVEYOR'S CERTIFICATE
