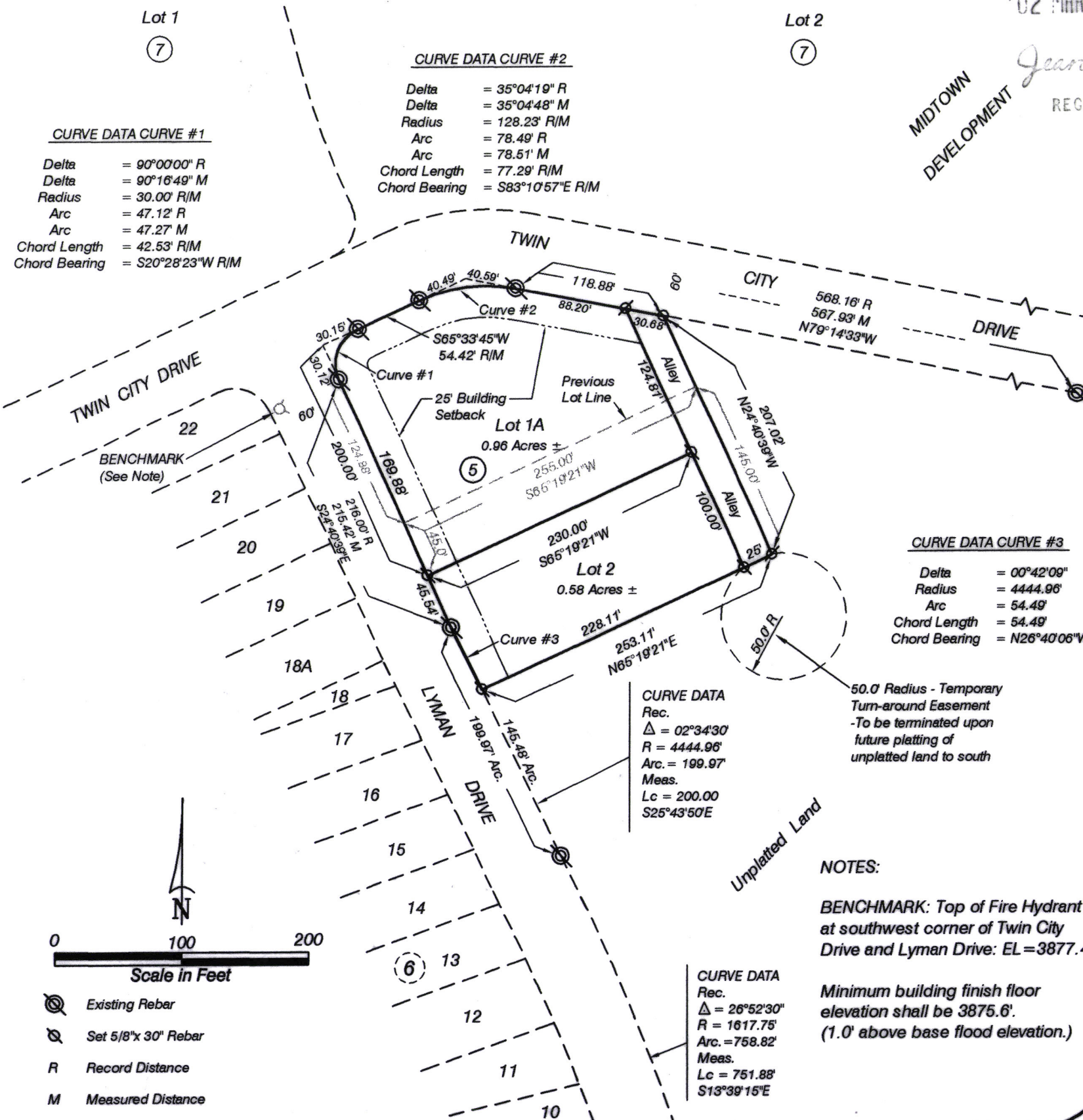

SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOTS 1A AND 2, BLOCK 5, MIDTOWN DEVELOPMENT, an Addition to the City of Gering, Nebraska, a Replat of Lot 1, Block 5, and unplatted land situated in the Southeast Quarter of Section 26, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, said unplatted land more particularly described as follows:

Commencing at the Northwest Corner of Lot 1, Block 5, Midtown Development, as previously platted, thence southerly on the west line of said Lot 1, Block 5, on an assumed bearing of S24°40'39"E, a distance of 124.88 feet, to the Southwest Corner of said Lot 1, Block 5, said point also being the POINT OF BEGINNING, thence continuing on last described course and on the east right of way line of Lyman Drive, as platted, a distance of 90.54 feet, to the point of curvature of a curve to the right, said curve having a central angle of 00°42'09", a radius of 4444.96 feet, a chord length of 54.49 feet, and a chord bearing of S26°40'06"E, thence continuing on arc of said curve, and east right of way line of Lyman Drive, an arc distance of 54.49 feet, thence bearing N65°19'21"E, a distance of 253.11 feet, thence bearing N24°40'39"W, a distance of 145.00 feet, to the Southeast Corner of the right of way line of a 25.00 foot alley previously platted, thence bearing S65°19'21"W, on the south line of said 25.00 foot alley and said Lot 1, Block 5, a distance of 255.00 feet, to the point of beginning, containing an area of 0.85 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number. That the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.


OWNER'S STATEMENT

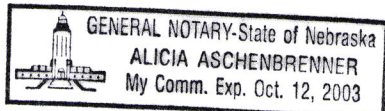

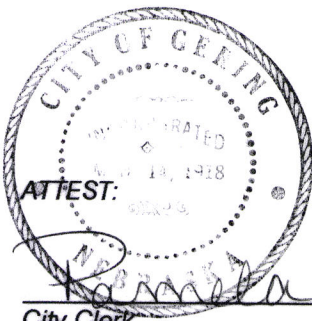
