


A part of the North half of the Northeast Quarter (N1/2 NE1/4) Section 22, Township 22 North, Range 55 West of the 6th Principal Meridian, Scottsbluff, Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Northwest corner of the NE1/4 of said Section 22; thence S88°24'46"E on the North line of said NE1/4 a distance of 530.37 feet to the POINT OF BEGINNING of this description; thence continuing S88°24′46″E on said North line a distance of 133.34 feet to the intersection of said North line with the southerly right—of—way line of the Burlington Northern Santa Fe Railroad; thence S44°19′47″E on said southerly right—of—way line a distance of 1390.84 feet to the intersection of said southerly right—of—way line a distance of Winter's Creek Irrigation Ditch; thence N88° 20′35″W on said northerly right—of—way line a distance of 1140.51 feet; thence N02°03′58″E a distance of 966.37 feet to the point of beginning, containing 14.138 real world acres, more or less.
