

Stott a Nebraska Registered Land Surveyor meteby certify that I have surveyed and prepared a plat for street dedication of Lot 13, Terry's Addition and a tract of land situated in the Southeast Quarter of Section 26, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows: Beginning at the Southwest corner of Lot 13, Terry's Addition, thence westerly on an extension of the South line of said Lot 13, a distance of 100.0 feet, thence a deflection angle right of 90°-00", a distance of 25.0 feet, thence a deflection angle right of 90°-00', a distance of 100.0 feet to the Northwest corner of said Lot 13, thence southerly on the West line of said Lot 13, a distance of 25.0 feet to the point of beginning.
