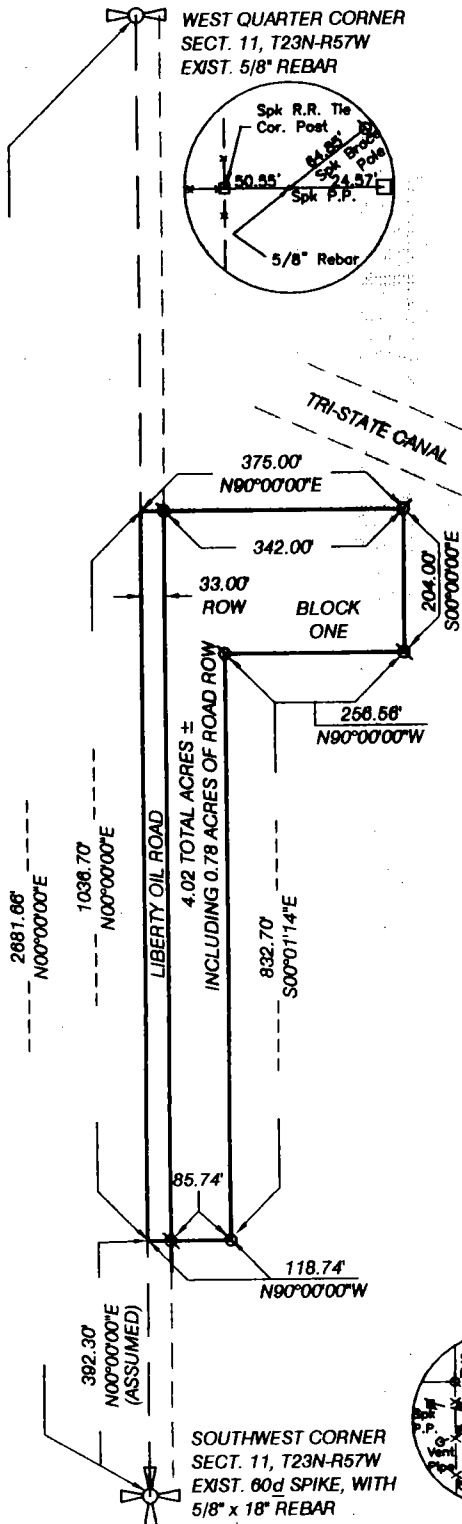

SURVEYOR'S CERTIFICATE

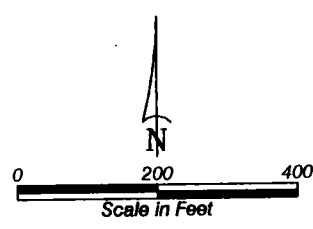
I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify I have surveyed a Tract of Land situated in the West half of the Southwest Quarter of Section 11, Township 23 North, Range 57 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Southwest Corner of Section 11, thence northerly on the West line of Section 11, on an assumed bearing of N00°00'00"E, a distance of 392.30 feet, to the Point of Beginning, thence continuing on said West line of Section 11, bearing N00°00'00"E, a distance of 1036.70 feet, thence bearing N90°00'00"E, a distance of 375.00 feet, thence bearing S00°00'00"E, a distance of 204.00 feet, thence bearing N90°00'00"W, a distance of 256.56 feet, thence bearing S00°01'14"E, a distance of 832.70 feet, thence bearing N90°00'00"W, a distance of 118.74 feet, to the Point of Beginning, containing an area of 4.02 acres more or less.


OWNER'S STATEMENT

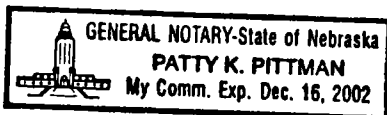





