

Beatty, a Nebraska Registered Land Surveyor, hereby certify I have surveyed and prepared a plat of LOT 1, MICKEY SUBDIVISION, a Subdivision of part of Tract 4, Steele Tracts in the City of Gering, Scotts Bluff County, Nebraska, situated in the Northwest Quarter of the Northeast Quarter of Section 34, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, said Lot 1, Mickey Subdivision more particularly described as follows:

Beginning at the point of intersection of the west line of Tract 4, Steele Tracts and the north right of way line of Country Club Road, as shown in Deed Book 185, Page 692, Scotts Bluff County Register of Deed Office, and said north right of way line being 33.00 feet north of the centerline of the existing Country Club Road, thence northerly on the west line of Tract 4, Steele Tracts, on an assumed bearing N00°47'04"E, a distance of 144.80 feet, thence bearing N89°55'40"E, a distance of 143.97 feet, thence bearing S00°00'59"E, a distance of 144.93 feet, to the point of intersection with the north right of way line of Country Club Road, thence westerly on said north right of way line, bearing S89°59'01"W a distance of 145.99' feet, to the Point of Beginning, containing an area of 0.48 acres, more or less.
