

SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of **BLOCK ONE**, **MEYER SUBDIVISION**, situated in the the Southeast Quarter of Section 28, Township 23 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows

Commencing at the South Quarter corner of Section 28, thence easterly on the south line of Section 28, on an assumed bearing of S88°39'01"E, a distance of 25.0 feet, to the point of intersection with the east line of a tract of land described in Miscellaneous Book 145, page 268, and said point also being the Point of Beginning, thence bearing S88°39'01"E, on the south line of Section 28, a distance of 490.30 feet to the point of intersection with the centerline of an irrigation lateral, thence northerly on centerline of said irrigation lateral, bearing N09°05'30"E, a distance of 220.53 feet, to the point of curvature of a tangent curve to the left, said curve having a radius of 285.00 feet, a central angle of 28°19'01", chord length of 139.42 feet and a chord bearing of N05°04'01"W, thence northwesterly on said centerline of lateral, and on arc of said curve, a distance of 140.85 feet, thence bearing N19°13'31"W, on said centerline of lateral, and on arc of said curve, a distance of 140.85 feet, thence bearing N19°13'31"W, on said centerline of lateral, a distance of 362.16 feet, thence bearing N22°46'07"W, on said centerline of lateral, a distance of 362.16 feet, thence bearing N22°46'07"W, on said centerline of lateral, a distance of 9.65 feet, to the point of intersection with the southeast corner of said referenced Tract of land as described in Misc.
