



## SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of BLOCKS 1 AND 2, MATHERS ADDITION to the City of Gering, Scotts Bluff County, Nebraska, situated in the part of the South Half of the Northwest Quarter, and the West Half of the West Half of the Southwest Quarter of the Northeast Quarter, and part of the Northeast Quarter of the Southwest Quarter, all in Section 35, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the Center Quarter corner of Section 25, thence easterly on the south line of the Northeast Quarter of Section 35, on an assumed bearing N89°16'16"E, a distance of 330.86 feet, to the Southeast corner of the West Half of the West Half of the Southwest Quarter of the Northeast Quarter of Section 35, thence northerly on said east line of the west half of the west half of the Southwest Quarter of the Northeast Quarter of Section 35, bearing N00°22'44"W, a distance of 1277.38 feet, to the point of intersection with the south Right of Way line of Country Club Road, as recorded in Deed Book 186, Page 15, Scotts Bluff County Register of Deeds Office. thence westerly on said south Right of Way line, bearing \$89°01'31"W, a distance of 331.14 feet, to the point of intersection with the North - South centerline of Section 35, thence bearing S89°14'13"W, on the south Right of Way line of Country Club Road, a distance of 1063.27 feet, to the point of intersection with the Northeasterly Right of Way line of Union Pacific Railroad, thence southeasterly on the said Railroad Right of way line and being 100 feet northeasterly of and parallel with said centerline, bearing \$30°54'37"E, a distance of 1923.33 feet, to the point of intersection with the northwest corner of Tract 3, Union Pacific Drain, as recorded in Instrument 2006-172. thence bearing N59°05'23"E, on the northwest line of said Tract 3, a distance of 100.00 feet, to the point of intersection with the east line of the Southwest Quarter of Section 35, said point being the northeast corner of said Tract 3, thence northerly on the east line of the Southwest Quarter of Section 35, bearing N00°19'39"W, a distance of 337.04 feet, to the Point of Beginning, containing an area of 31.60 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 300 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number and that the boundary of the plat is shown with a heavy solid line with dashed lines heing for orientation purposes only. That all corners found or set are marked as shown.
