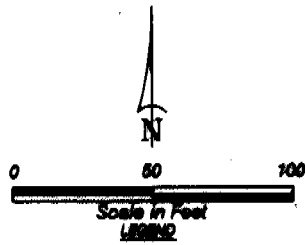

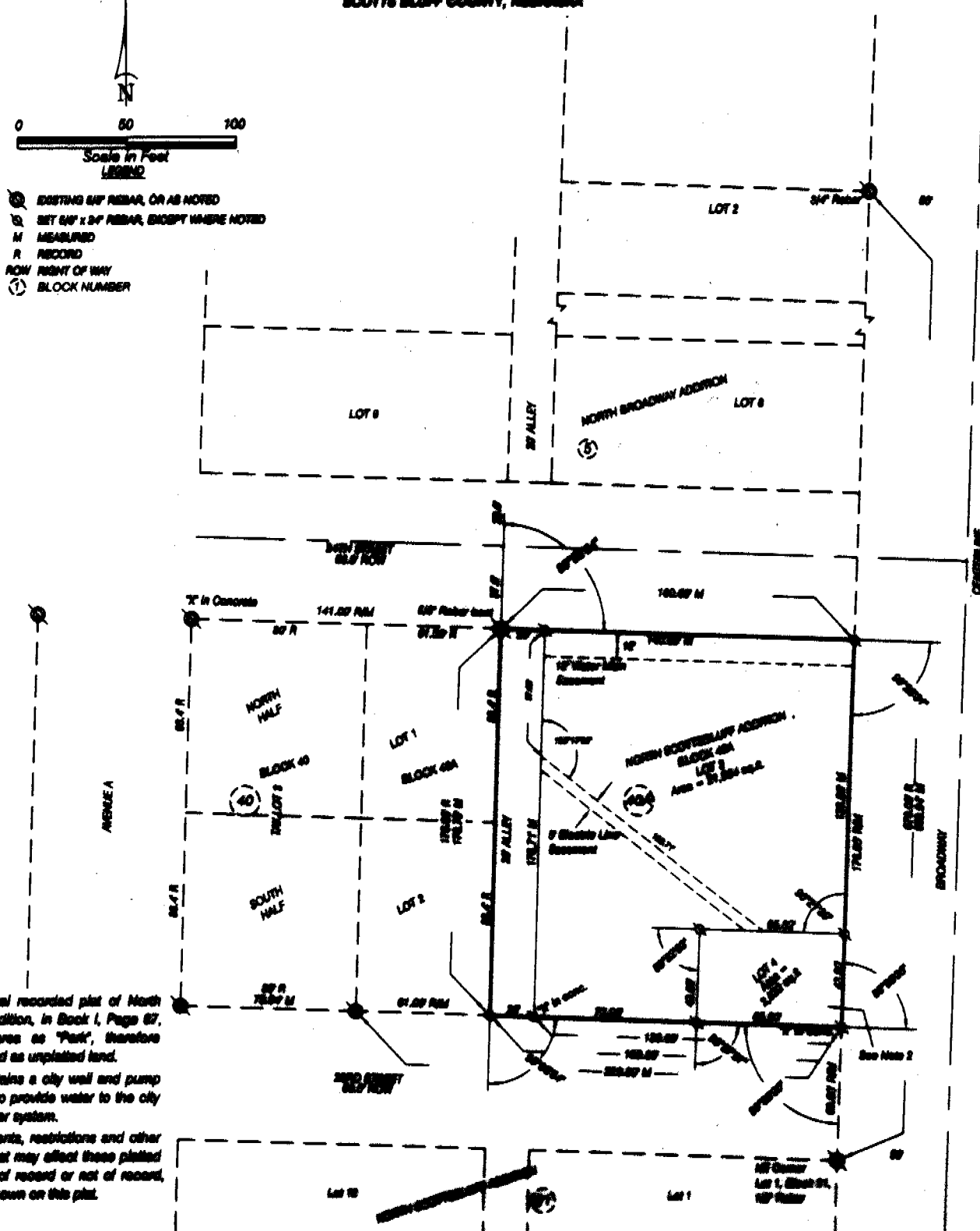

SURVEYOR'S CERTIFICATE

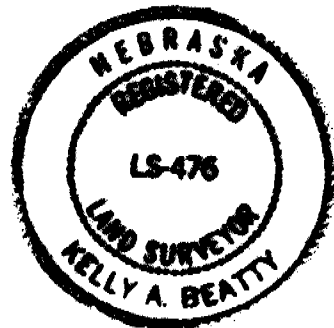
I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOTS 3 AND 4, BLOCK 40A, NORTH SCOTTSSLUFF ADDITION IN THE CITY OF SCOTTSSLUFF, SCOTTSSLUFF COUNTY, NEBRASKA, situated in the Southwest Quarter of the Northeast Quarter of Section 23, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Beginning at the southeast corner of Lot 2, Block 40A, North Scottsbluff Addition in the City of Scottsbluff, Scotts Bluff County, Nebraska, said corner being on the north right of way line of 23rd Street, thence northerly on the east line of Lots 1 and 2, Block 40A, a distance of 178.70 feet, as measured, (178.80' Record) to the northeast corner of Lot 1, Block 40A, said corner being on the south right of way line of 24th Street, thence a deflection angle right 89°52'04", on the south right of way line of 24th street, a distance of 160.69 feet, to the point of intersection with the west right of way line of Broadway, thence a deflection angle right, 90°23'31" on the west right of way line of Broadway, a distance of 178.80 feet, to the point of intersection with the north right of way line of 23rd Street, thence a deflection angle right 89°38'30" on the north right of way line of 23rd Street, a distance of 158.89 feet, to the Point of Beginning, containing an area of 0.85 acres, more or less.

That the accompanying plat is a true delineation of such survey drawn to a scale of 50 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number and that the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.

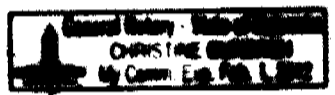
