

SURVEYOR'S CERTIFICATE

I, Kelly Beatty, a Nebraska Registered Land Surveyor, hereby certify I have surveyed and prepared a plat of SOUTH HALF OF MARTHA ROAD, a Replat of part of Lot 64, Terry's Addition and unplatted land in the City of Terrytown, Nebraska, situated in the Northwest Quarter of the Northeast Quarter of Section 35, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska more particularly described as follows:

Beginning at a point on the north line of Lot 64, Terry's Addition in the City of Terrytown, Scotts Bluff County, Nebraska, said point being 35.00 feet west of the northeast corner of Lot 64, as originally platted, thence westerly on the north line of said Lot 64, a distance of 190.00 feet, to the northwest corner of said Lot 64, thence continuing westerly on the westerly extension of the north line of Lot 64, a distance of 250.84 feet, as measured, to the point of intersection with the east right of way line of Lake Drive, a distance of 25.00 feet, to the point of intersection with the westerly thence southerly on the east right of way line of Lake Drive, a distance of 25.00 feet, to the point of intersection with the westerly extension of the south line of said Lot 64, thence easterly on said extension line, a distance of 250.22 feet, as measured, to the southwest corner of said Lot 64, thence continuing easterly on the south line of said Lot 64, to the point of intersection with the west right of way line of highway as described in Deed Book 145, Page 256, thence northerly on said right of way line, to the Point of Beginning, containing an area of 0.25 acres, more or less.

That the accompanying Plat is a true delineation of said survey, drawn to a scale of 60 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number.
