

NOTE 1: There appears to be a 2' discrepancy in north-south measurement versus the original plat dimensions given for lots 6 and 7. According to the original plat, the total width of Lots 6 and 7 should be 62.0 feet (Lot 7 - 30.00', Lot 6 - 32.00'). However, deeds given in 1934 show ownership of Lot 6 (33') and Lot 7 of Lot 7, have a total of 61.0', and Lot 7 being divided as the South 45.0' of Lot 7, this total being 66.0'. However, the plat shows a total width of 63.00'. The two deeds were given by the same owner in two different periods within 8 months of each other in Grand Duchy St. Page 683 and 685. As such, it appears they recognized the difference, as the deed dimensions match the existing improvements in the field. Also, the measurements from existing plat to the north also appear to confirm the deed descriptions.

NOTE 2: All easements, restrictions and other encumbrances that may affect these platted lots, that are of record or not of record, may not be shown on this plat.




