



- for the benefit and use of owners of Lots 1 and 2, Block 1, and Blooks 2 and 3, Fox Hill Subdivision until at such time as Fox Hill Lane is constructed. The 20' driveway access will then be abandoned and shall be for use by Block 2 only. Fox Hill Lane shall be constructed as a non-hard surface road until further development and subdivision of Blocks 2 and 3, or as required by the City of Gering. It will be maintained by the owners within the subdivision until annexation and construction of road to
- The existing home site on Lot 1, Block 1 is serviced by its own septic system. Any additional housing development within this subdivision will require private septic systems, approved and constructed to City and State regulations. No public sewer main lines are proposed at this time for this subdivision.
- extending from the water main in County Road P, to the existing house situated on Lot 1, Block 1. This line will continue to serve Lots 1 and 2, Block 1 until further development and subdivision of Blocks 2 and 3. At that time, a new water main will need to be constructed in Fox Hill Lane to serve the new lots. The new main will need to be installed as per City of Gering and State
- 4. The land is surfaced drained at this time, with any excess run-off draining into the drainage ditch located along the south side of County Road 'P'. The land slopes from south to north, with good slope. No public or private drainage improvements are proposed with the relopment of Lots 1 and 2, Block 1. subdivision and development of lots in Blocks 2 and 3 may require storm drainage improvements per city requirements.
