Affidavit

- I, Dustin L. Beaudette, a Nebraska Professional Land Surveyor, being first duly sworn on his oath, states as follows:
 - 1. Affiant is employed by M.C. Schaff & Associates, Inc., Scottsbluff, Nebraska, and represents them in this affidavit.
 - 2. On or about February 20, 2002, a subdivision plat was done for LOTS 1A AND 1B, BLOCK 1, A REPLAT OF LOT 1 AND THE NORTH 5 FEET OF LOT 2, BLOCK 1, McCLENAHAN ADDITION TO THE CITY OF SCOTTSBLUFF, SCOTTS BLUFF COUNTY, NEBRASKA, by Kelly A. Beatty, a Nebraska Registered Land Surveyor, and then recorded at the Scotts Bluff County Register of Deeds office as Instrument 2002-2141, on March 20, 2002.
 - 3. On or about March 24, 2021, a subdivision plat was done for LOT 12A, BLOCK 1, McCLENAHAN ADDITION, A REPLAT OF LOT 12 BLOCK 1, AND THE NORTH HALF OF LOT 11, BLOCK 1, MCCLENAHAN ADDITION TO THE CITY OF SCOTTSBLUFF, SCOTTS BLUFF COUNTY, NEBRASKA, by Dustin L. Beaudette, a Nebraska Registered Land Surveyor, and then recorded at the Scotts Bluff County Register of Deeds office as Instrument 2021-1737, on April 1, 2021.
 - 4. After recording of these final plats, an error was found regarding the official name of the subdivision.
 - 5. According to the owner's statement of the original plat, recorded in Deed Book I, Page 78, and an affidavit recorded in Miscellaneous Book 49, Page 381, the official name of the subdivision is McClenahan's Addition No. 1.
 - 6. The corrected subdivision labels are as follows:

LOTS 1A AND 1B, BLOCK 1, A REPLAT OF LOT 1 AND THE NORTH 5 FEET OF LOT 2, BLOCK 1, McCLENAHAN'S ADDITION NO. 1, TO THE CITY OF SCOTTSBLUFF, SCOTTS BLUFF COUNTY, NEBRASKA

AND

LOT 12A, BLOCK 1, McCLENAHAN'S ADDITION NO. 1, A REPLAT OF LOT 12, BLOCK 1, AND THE NORTH HALF OF LOT 11, BLOCK 1, McCLENAHAN'S ADDITION NO. 1, AN ADDITION TO THE CITY OF SCOTTSBLUFF, SCOTTS BLUFF COUNTY, NEBRASKA.

7. This affidavit shall be indexed against the subdivision final plats as recorded in Instrument 2002-2141 and Instrument 2021-1737, to correct the subdivision labels as referenced in item 6 above.
