## SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of Blocks 7 and 8, Hiner Agri—Park, situated in part of the Southwest Quarter of Section 15, and the Northwest Quarter of Section 22, all in Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

## BLOCK 7

A tract of land situated in the Northwest Quarter of Section 22, Township 22 North, Range 55 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the northwest corner of said Section 22, thence easterly on the north line of Section 22, a distance of 60.00 feet to the point of intersection with the east right of way line of the South Beltline Highway, said point also being the POINT OF BEGINNING, thence continuing easterly on the north line of Section 22, a distance of 172.37 feet, to the point of intersection with the centerline of the Winter Creek Canal, as described in Deed Book 166, Page 426, thence a deflection angle right 58°58'08", on said centerline, a distance of 232.72 feet, thence a deflection angle left 12°56'45", on said centerline, a distance of 433.24 feet, thence a deflection angle right 19°40'20", on said centerline, a distance of 131.44 feet, thence a deflection angle left 13.56'10", on said centerline, a distance of 304.25 feet, thence a deflection angle left 16.06'33", on said centerline, a distance of 65.19 feet, to the point of intersection with the northerly extension of the east line of Block 6, Hiner Agri-Park, as platted, thence a deflection angle right 56°41'51", on said northerly extension of the east line of Block 6, Hiner Agri-Park, a distance of 144.39 feet, to the northeast corner of Block 6, Hiner Agri-Park, thence a deflection angle right 86°43'04", on the north line of Block 6, Hiner Agri-Park, and the westerly extension thereof, a distance of 239.73 feet, as measured, to the northwest corner of Hiner Drive, as platted, thence a deflection angle left 86°44'15", on the west right of way line of Hiner Drive, a distance of 200.07 feet, as measured, to the point of intersection with the north right of way line of 24th Street, as platted, thence a deflection angle right 86°47'25", as measured, on said north right of way line, a distance of 684.88 feet, as measured, to the point of intersection with the east right right of way line of South Beltline Highway, thence a deflection angle right 93'08'31" on said east right of way line, a distance of 1267.57 feet, to the POINT OF BEGINNING, containing an area of 17.49 acres, more or less.

Commencing at the southwest corner of said Section 15, thence easterly on the south line of Section 15, a distance of 60.00 feet, to the point of intersection with the east right of way line of the South Beltline Highway, said point also being the POINT OF BEGINNING, thence continuing easterly on the south line of Section 15, a distance of 172.37 feet, to the point of intersection with the centerline of the Winter Creek Canal, as described in Deed Book 166, Page 426, thence a deflection angle left 127.55.09", on said centerline, a distance of 142.38 feet, thence a deflection angle left 08.23.30", on said centerline, a distance of 116.00 feet, to the point of intersection with the east right of way line of the South Beltline Highway, thence a deflection angle left 133.24.00", on said east right of way line, a distance of 192.46 feet, to the POINT OF BEGINNING, containing an area of 0.41 acres, more or less.
