

Plat of BLOCKS 1, 2 & 3, AULICK'S ADDITION

LEGAL DESCRIPTION

A tract of land accreted to Government Lot 3 and situated in the E 1/2 of the NE 1/4 and a portion of the NE 1/4 of SE 1/4 of Section 27, Township 22 North, Range 55 West of the 6th Principle Meridian, Scotts Bluff County, Nebraska, more particularly

Beginning at the Northeast corner of Section 27, thence S03'47'30"E (Assumed Basis of Bearing) along the East line of Section 27 a distance of 1246.25 feet; thence N72'26'56"W a distance of 71.04 feet to the intersection of the southerty right-of-way (ROW) line of South Beltine Highway West with the westerly ROW line of U. S.
