

SURVEYOR'S CERTIFICATE

I, Kelly A. Beatty, a Nebraska Registered Land Surveyor, hereby certify that I have surveyed and prepared a plat of LOTS 1 AND 2, HENNINGS SUBDIVISION, situated in Government Lot 3 of Section 18, Township 22 North, Range 54 West of the 6th P.M., Scotts Bluff County, Nebraska, more particularly described as follows:

Commencing at the Southwest Corner of Section 18, thence northerly on the west line of the Southwest Quarter of Section 18, a distance of 1670.00 feet, thence a deflection angle right 90°00'00", a distance of 33.00 feet, to the POINT OF BEGINNING, thence continuing easterly on last described course, a distance of 333.71 feet, thence a deflection angle left 90°00'00", a distance of 208.71 feet, as measured, to the point of intersection with the easterly extension of the south line of Block 1, Gable Heights Addition to Scotts Bluff County, Nebraska, thence a deflection angle left 90°00'00", as measured, on said extension line and the south line of Block 1, Gable Heights Addition, a distance of 333.71 feet, to the southwest corner of said Block 1, Gable Heights Addition, said corner being 33.00 feet east of the west line of Section 18, thence a deflection angle left 90°00'00", on a line being 33.00 feet east of and parallel with the west line of Section 18, a distance of 208.71 feet, to the Point of Beginning, containing an area of 1.60 acres, more or less..

That the accompanying plat is a true delineation of such survey drawn to a scale of 100 feet to the inch. That all dimensions are in feet and decimals. That each lot and block has its own number and that the boundary of the plat is shown with a heavy solid line with dashed lines being for orientation purposes only. That all corners found or set are marked as shown.
