I HEREBY CERTIFY, that on the 17th day of April, A D 1929, I surveyed SECOND HALL ADDITION to Scottsbluff, Nebraska, situated on a part of the NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of section 26, Township 22 North of Range 55 West of the 6th P.M. more particularly described as follows: Beginning at a point 253 feet south and 33 feet west of the N E corner of said section 26, thence south a distance of 404 feet, thence west a distance of 165 feet, thence north a distance of 404 feet, thence east a distance of 165 feet to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 50 feet to an inch. 1x1x15" fir stakes are driven well into the ground at front corners of each lot. The width of the driveways and the dimensions of the lots are indicated on the plat in feet and decimals. Each lot bears its own number.

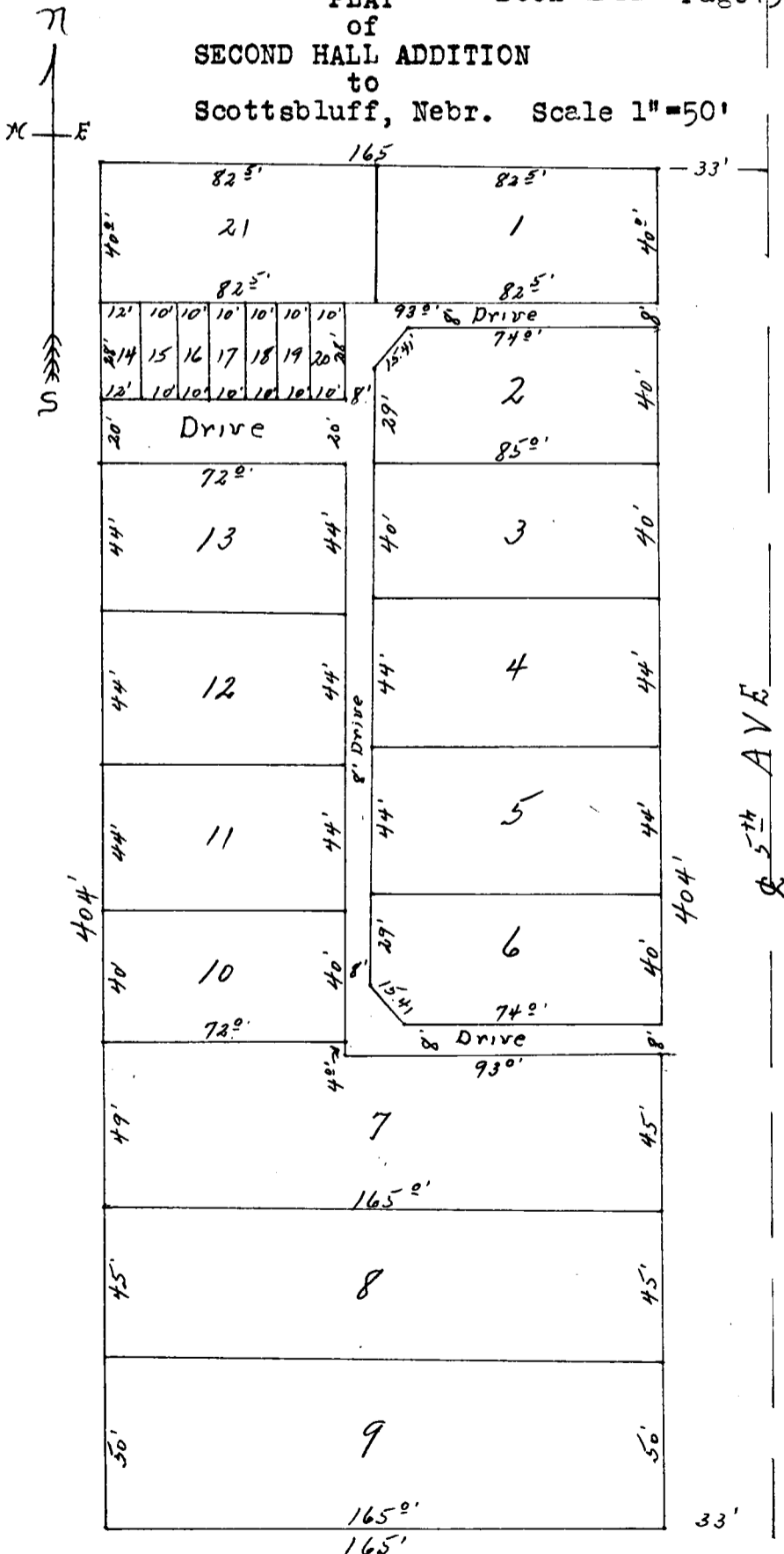
