

RESOLUTION

WHEREAS, on the 12th day of August, 1919, by a certain plat duly recorded in the office of the Register of Deeds, Scotts Bluff County, Nebraska, in Volume 6, Page 234 of the Deed Record, and was dedicated to public use for highway purposes in said county, a certain tract of land situated in said county described as follows:

> A strip of land, beginning at a point 1320 feet north and 33 feet west of the Southeast corner of the $SW_{\frac{1}{4}}$ of Section 14, Township 22, Range 55, -thence running West and parallel with the South line of said Section 14 to a point 33 feet east of the west line of said Section 14,thence South 30 feet, thence east along a line parallel with the South Section line of said Section 14, to a point 1290 feet north and 33 feet west of the South East Corner of the Southwest Quarter of said Section 14, thence North 30 feet to the point of beginning,

and

WHEREAS said tract of land is un-used and has never been used for highway purposes in said county, and said tract is not needed for highway purposes, therefore,

BE IT RESOLVED by the County Board of County Commissioners of Scotts Bluff County, Nebraska, at a regular meeting of said Board held in the Court House of said County on this 28th day of April, 1947, that said tract of land above described be, and the same is hereby vacated and discontinued as a public road of said county
