

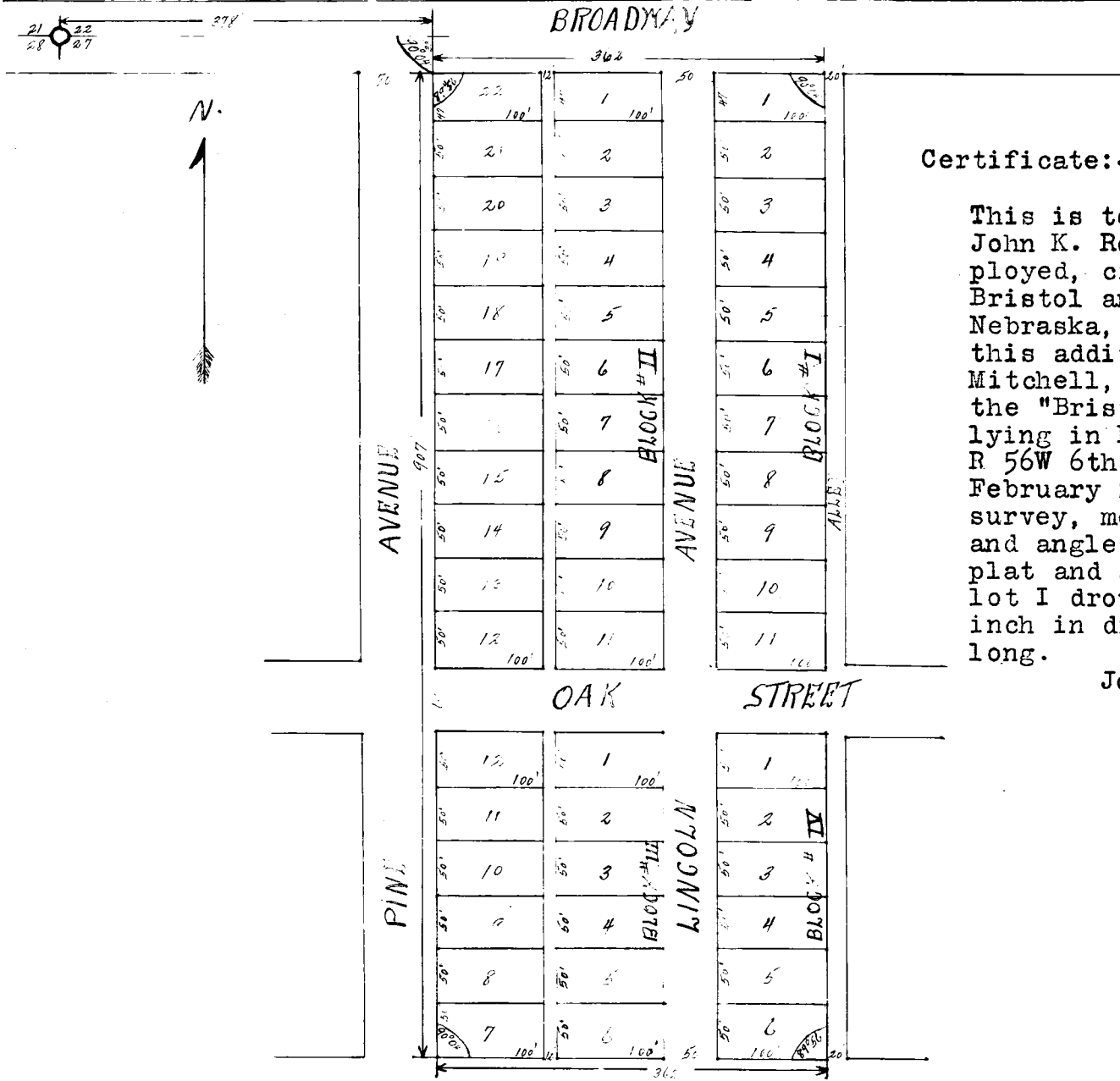

This is to certify that, I, John K. Rohrer was duly employed, civil engineer, by Bristol and Shafer of Mitchell, Nebraska, to survey and plat this addition to the City of Mitchell, Nebraska, known as the "Bristol and Shafer Addition, lying in NW $\frac{1}{4}$ NW $\frac{1}{4}$ Sec.27, T.23N., R 56W 6th P.M. and that on February 22 1919, I made the survey, measuring all distances and angles as shown on this plat and at each corner of each lot I drove an iron pipe 3/4 inch in diameter and 12 inches long.
