

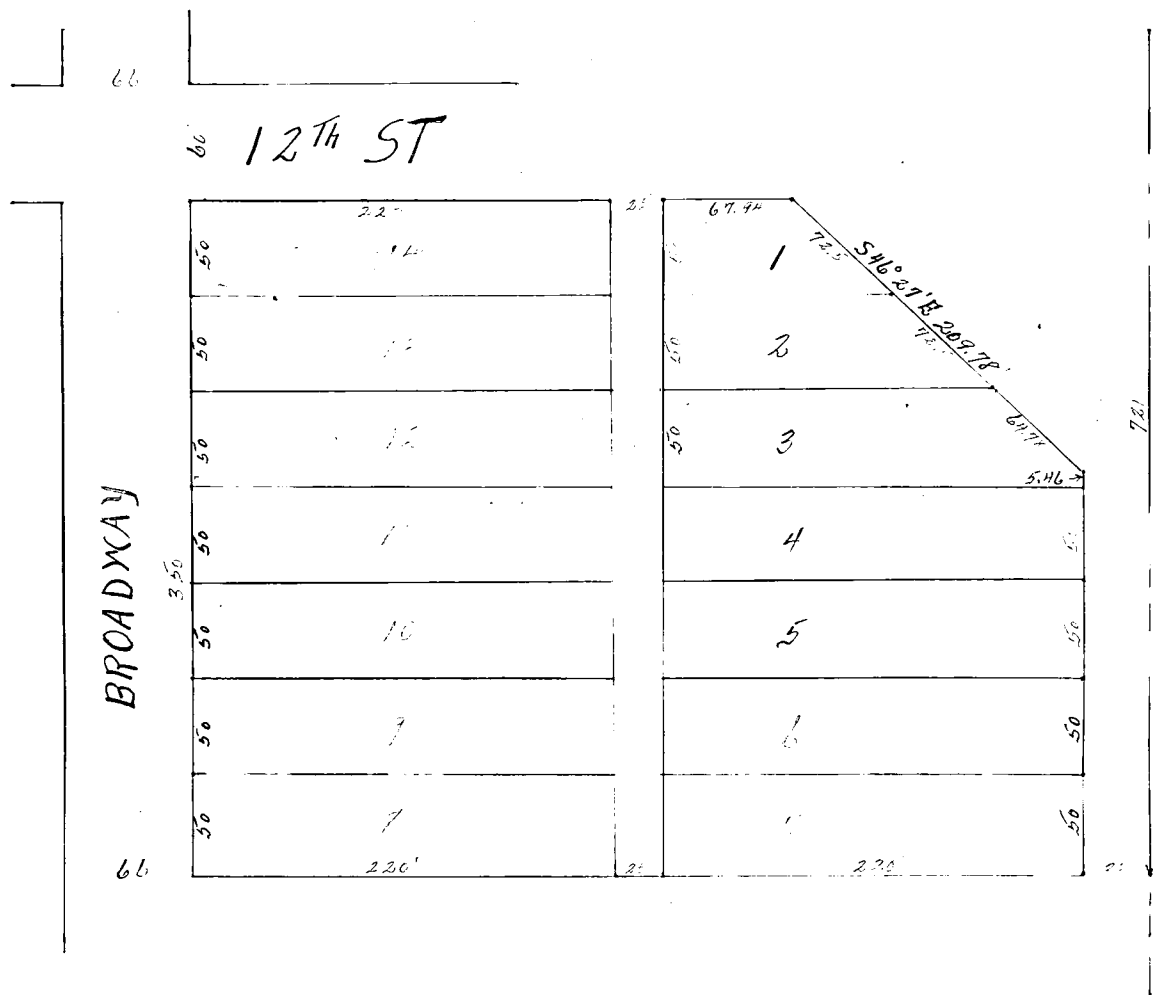

I hereby certify that on the 18 day of April, 1918 I surveyed the GUECK ADDITION to Scottsbluff, situated on a part of Sec. 26, Town 22 N., R. 55 W., described as follows: Beginning at a point 721 feet South and 33 feet West of the Northwest Corner of the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Sec. 26, Town 22 N., R. 55 W., thence West 465 feet, thence North 350 feet, thence East 312.94 feet, thence South 46° 27' East for a distance of 209.78 feet, thence South 205.46 feet to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 100 feet to an inch. Pine stakes are driven well into the ground at the front corners of each lot. The width of the alley and dimensions of the lots are indicated on the plat in feet and decimals. Each lot bears its own Number.
