

I HEREBY CERTIFY that on the 29th. day of March A. D. 1939 I accurately surveyed the NW 1/4 of Block 4, Beatty Tracts, inclusive to the City of Scottsbluff, Scotts Bluff County, Nebraska, situated on a part of the NE 1/4 of the NW 1/4 of Section 23, Township 22 north, Range 55 West of the 6th. P. M. in Scotts Bluff County, Nebraska, more fully described as follows:

Beginning at a point 261 ft. East and 518.1 ft. South of the Northwest corner of the Northeast 1/4 of the Northwest 1/4 of the said section 23, thence South a distance of 135 ft; thence East a distance of 140 ft; thence North a distance of 135 ft; thence west a distance of 140 ft. to point of beginning; That the above plat is a correct delineation of said survey drawn to a scale of 100 ft. to the inch, one 1/2" iron pipe stakes are driven 30 inches into the ground at the front corners of each Lot; That the Lots, Blocks, Streets, Avenues and Alleys are well and accurately staked off and marked and the dimensions thereof indicated in the plat in feet and decimal fractions of feet, and each Lot and Block bears its own number.


