

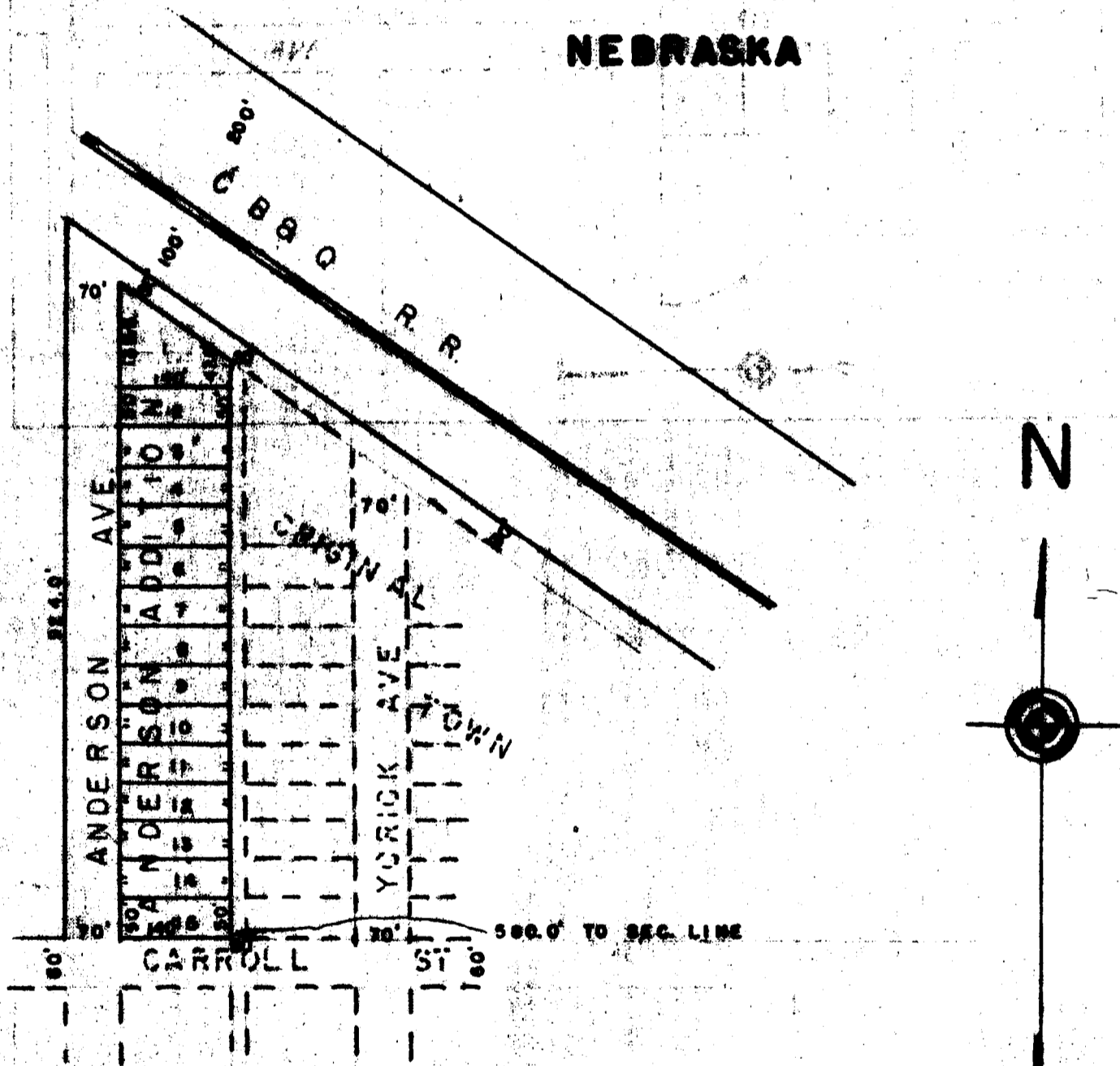

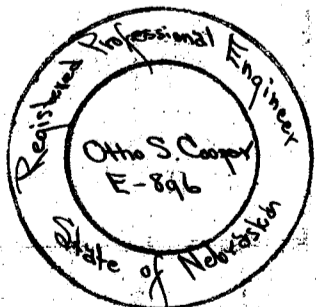

# PLAT OF ANDERSON ADDITION TO THE VILLAGE OF HENRY NEBRASKA

I, Hereby Certify, that on the 18th day of May, 1946, A. D., I surveyed lots 1 to 15, ANDERSON ADDITION to the Village of Henry, Nebraska, situated in Government Lot 1, Section 4, Township 23 N., Range 58 West of the 6th P.M., more fully described as follows:

Starting at a point on the north line of Carroll Street in the Village of Henry, Nebraska, and 580.0 feet west of the east line of Section 4, Township 23 North, Range 58 West of the 6th P.M.; thence, west along the north side of Carroll Street a distance of 210.0 feet; thence, north, parallel to the west line of Block 3, Original Town of Henry, Nebr., a distance of 924 feet to the south line of the right of way of the C. B. & Q. railroad; thence, in a southeasterly direction along the right of way of the C. B. & Q. railroad, to a point 20.0 feet west of the west line of Block 3, Original Town of Henry, Nebraska extended north; thence, south, 20 feet from and parallel to the west line of Block 3, Original Town of Henry Nebraska, to the point of beginning.

This plat is a true delineation of said survey drawn to a scale of one inch equals two hundred feet. Wood stakes are driven into the ground at the corner of each lot. The true demensions of each lot are shown on the plat and each lot bears its own number.
