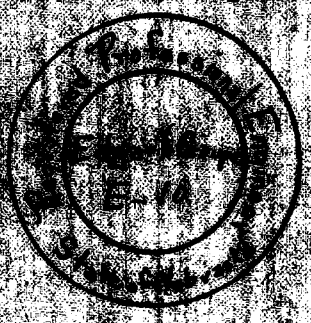
ENGINEER'S CERTIFICATE
