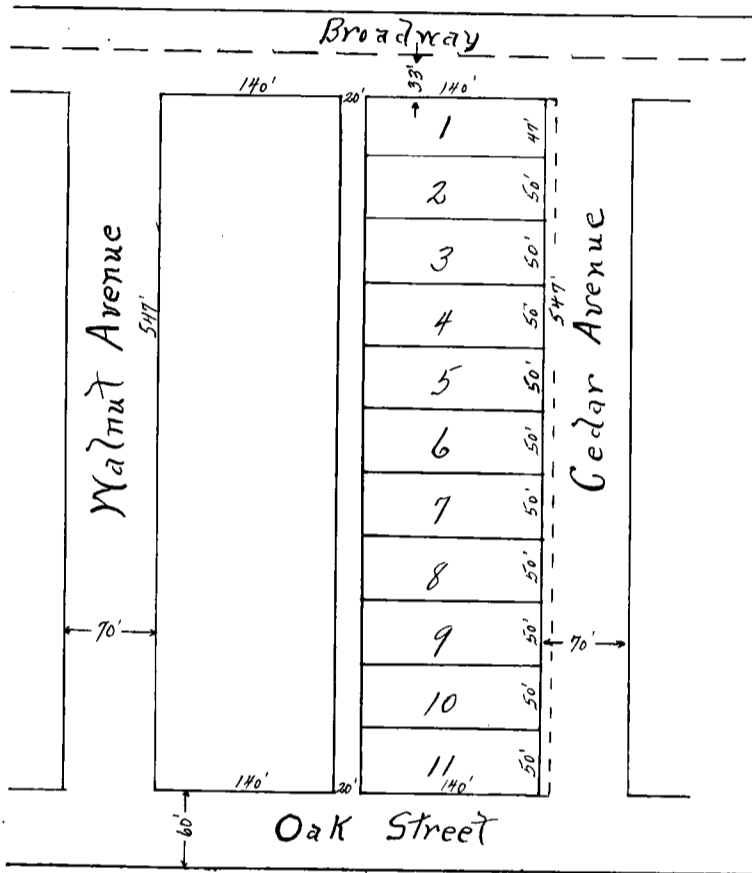

CERTIFICATE

This is to certify that, I, Irvin J. Matthews was duly employed, Civil Engineer, by Oliver P. Burrows of Mitchell, Nebraska, to survey and plat this Addition to the City of Mitchell, Nebraska, known as Park Addition, lying in the Northeast Quarter of the Northwest Quarter of Section 27 in Township 23 North, Range 56 West of the Sixth Principal Meridian, and that on May 30, 1919 I made the survey, measuring all distances as shown on this plat and at each corner of each lot I drove an iron pipe one-half inch in diameter and eighteen inches long.
