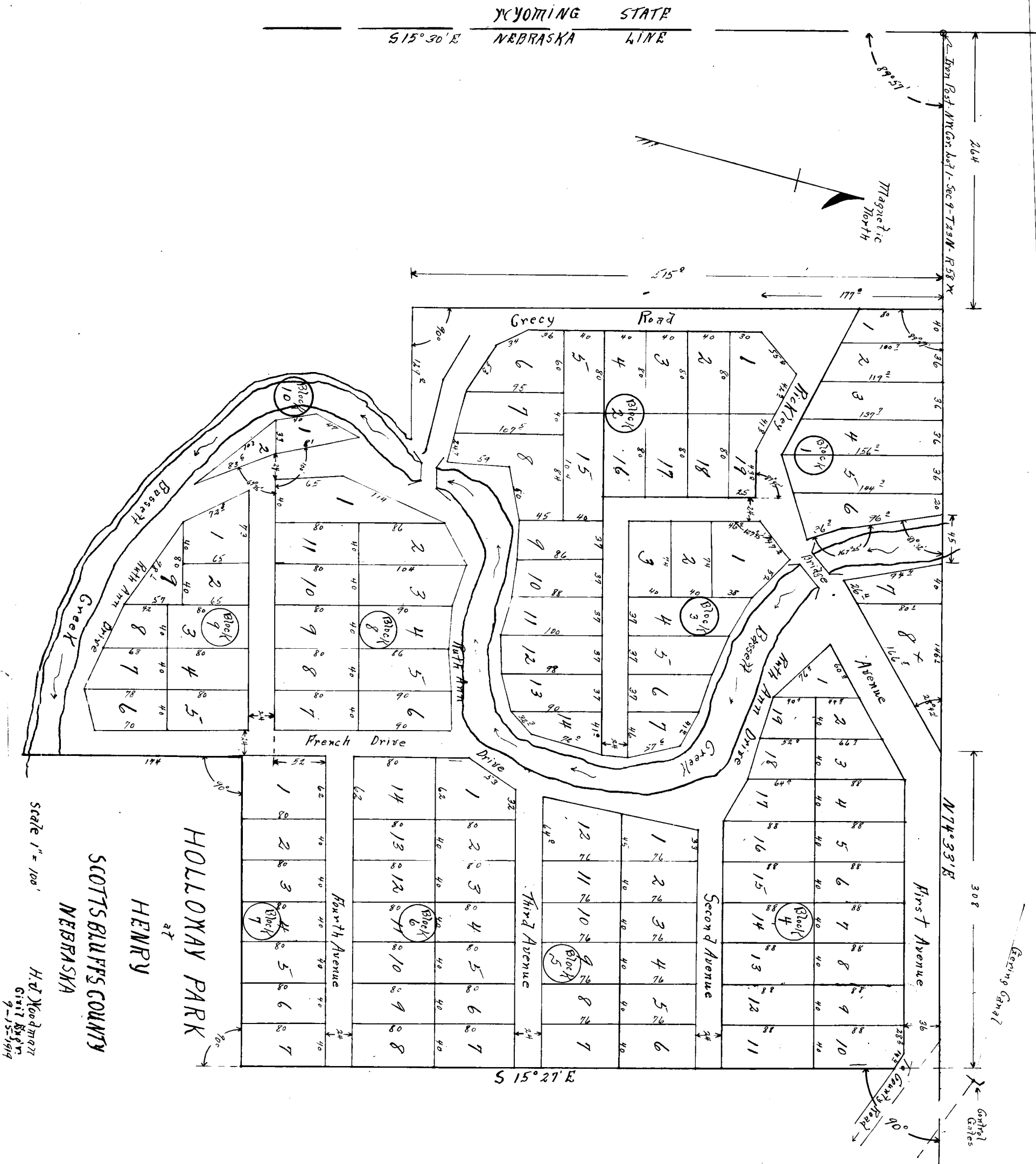

I hereby certify that, on the 6th day of September 1919 A. D., I finished the survey of Holloway Park, at Henry, Scotts Bluffs County, Nebraska, a subdivision of Lot 1, Section 9, Township 23 North, Range 58 West of the 6th Principal Meridian, Scotts Bluffs County, Nebraska, as shown on the attached Plat, which is a correct delineation of said survey drawn to a scale of 100 feet to the inch; a correct description of said tract as complete as practicable by meets and bounds, being as follows: beginning at the North-west corner of Lot 1, Section 9, Township 23 North, Range 57 West of the 6th Principal Meridian, Scotts Bluffs County, Nebraska, and running N. 74°33' E. a distance of 264 feet, along the North

line of said Section to a point designated as the North-west Corner of Holloway Park, from this point the West edge of Holloway Park runs S 15°30'E. for 515 feet on a line parallel to the West side of Lot 1, of said Section, (State Line), from this point which is the South-West corner of Holloway Park, the line bears N 74°33' E. a distance of 129 feet, to a point * 8 feet distant from the right hand (West side) bank of the Creek designated on the Plat as Bassett Creek; again from the point designated above as the North-west Corner of Holloway Park, the line bears N. 74°33'E. for 743.1 feet along the North side of said Lot and said Section, to a point which is the North-east Corner of said Park; from this point the line bears 90° to the right and runs S 15°27' E. a distance of 676 feet, from this point the line bears 90° to the right and runs S 74°33' W. for 302 feet on a line parallel to the North side of said Lot and said Section, from this point the line bears 90° to the left and runs S15°27' E. to a point 8 feet distant from the right hand (South side) bank of the creek designated as Bassett Creek on the Plat, from this point the line follows at a distance of 8 feet out, the contour of the right hand (South and West side) bank of the creek designated as Bassett Creek on the plat, to the point designated with an asterisk (*), above.

The width of streets and dimensions of lots are indicated on the Plat by feet and decimals. Each lot and block bears its own number. Steel pins about 14 inches long cut from $\frac{3}{4}$ inch stock are driven well into the ground at the front and outside corners.
