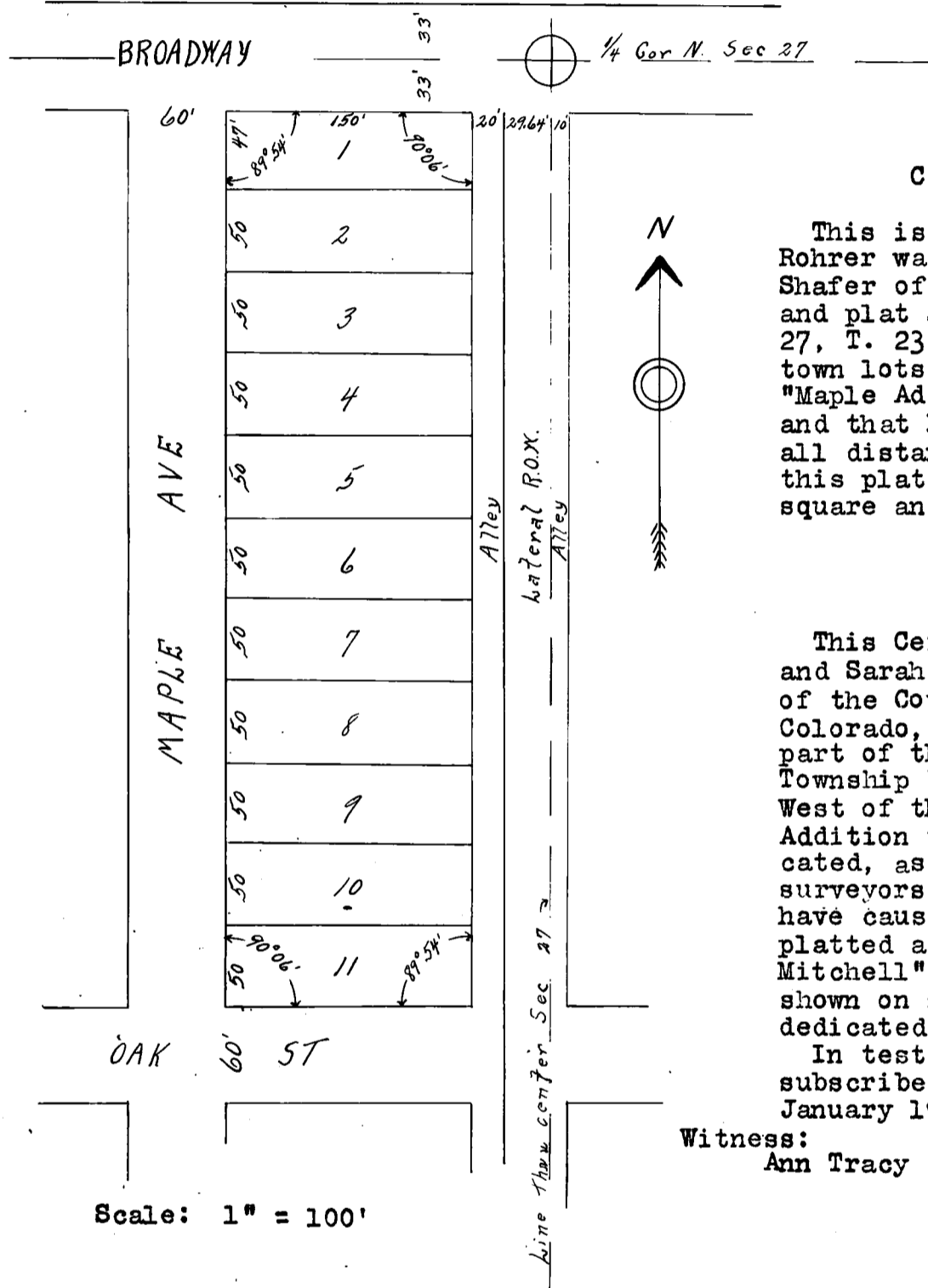

### CERTIFICATE

This is to certify that I, John K. Rohrer was duly employed by Bristol and Shafer of Mitchell, Nebraska, to survey and plat a part of the NE 1/4 NW 1/4 of Sec. 27, T. 23 N., R. 56 W. 6th P.M. into town lots, the tract to be known as "Maple Addition" to the City of Mitchell, and that I made the survey, measuring all distances and angles as shown on this plat and drove a fir stake 1 1/2" square and 12" long at each lot corner.

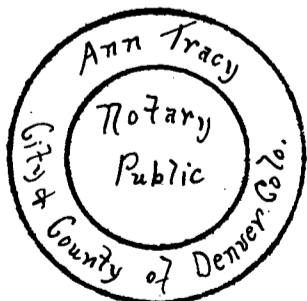
