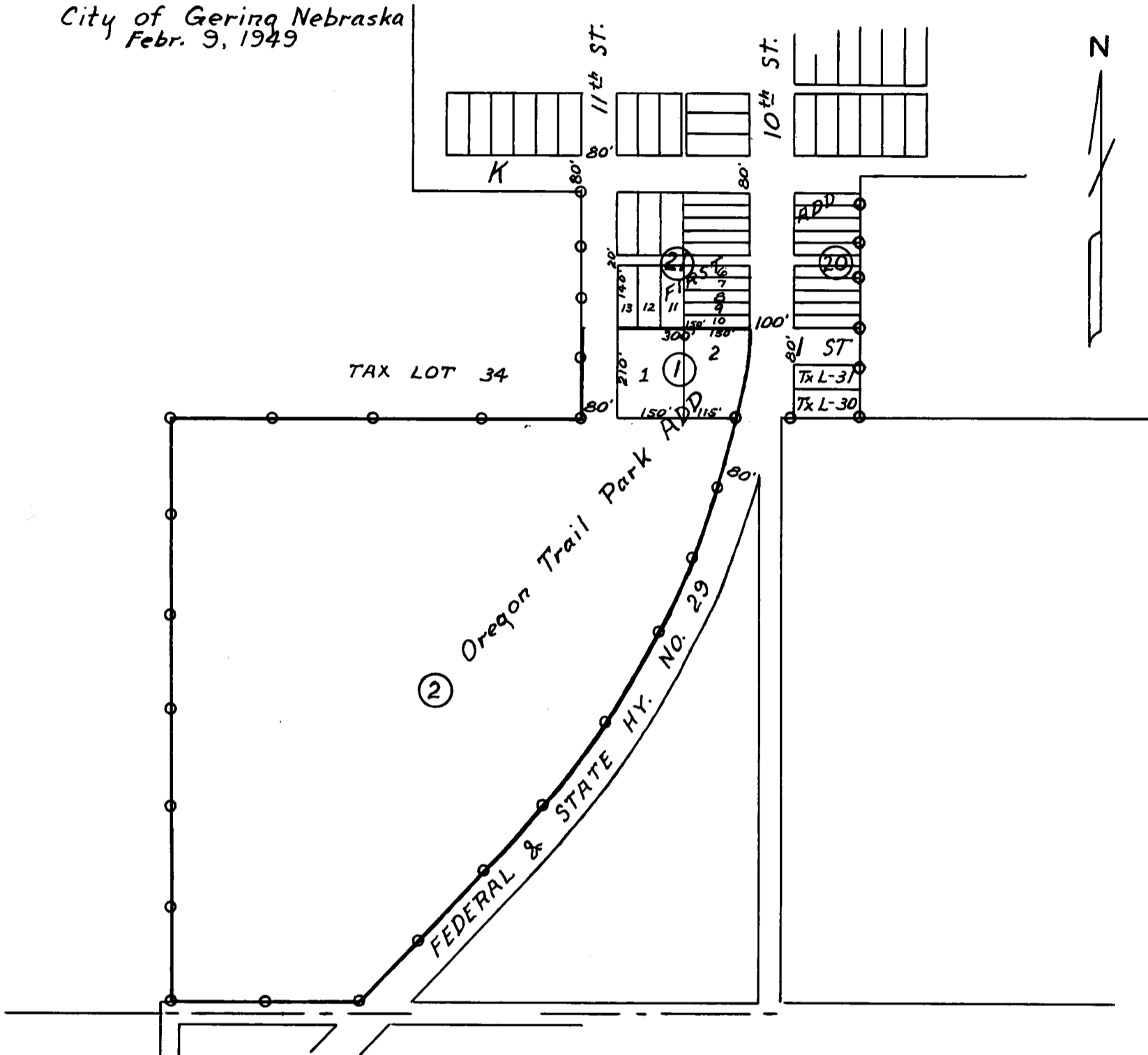

I certify that, on the 21 day of February, 1949, I surveyed Oregon Trail Park Addition to the City of Gering, Nebraska, located in the Southeast Quarter of Section 2, Township 21 North, Range 55 West of the 6th P. M., more fully described as follows:

A tract of land starting at a point on the Southeast corner of Lot 10, Block 21, First Addition to the City of Gering, Nebraska; thence West 380 feet parallel to the South line of K Street; thence South 210 feet; thence West to the Northwest corner of the Southwest Quarter of the Southeast Quarter of Section Two, Township twenty-one, North, Range fifty-five West of the 6th Principal Meridian; thence South to the Southwest Corner of said Southwest Quarter of the Southeast Quarter of Section two; thence East to the West line of State Highway No. 29; thence in a Northeasterly direction along the West line of said highway to the point of beginning.

And this plat is a true delineation of said survey drawn to a scale of one inch equals three hundred feet. The width of the street and the dimensions of the lots are indicated on the plat in feet and decimals, and each block and lot bears its own number.
