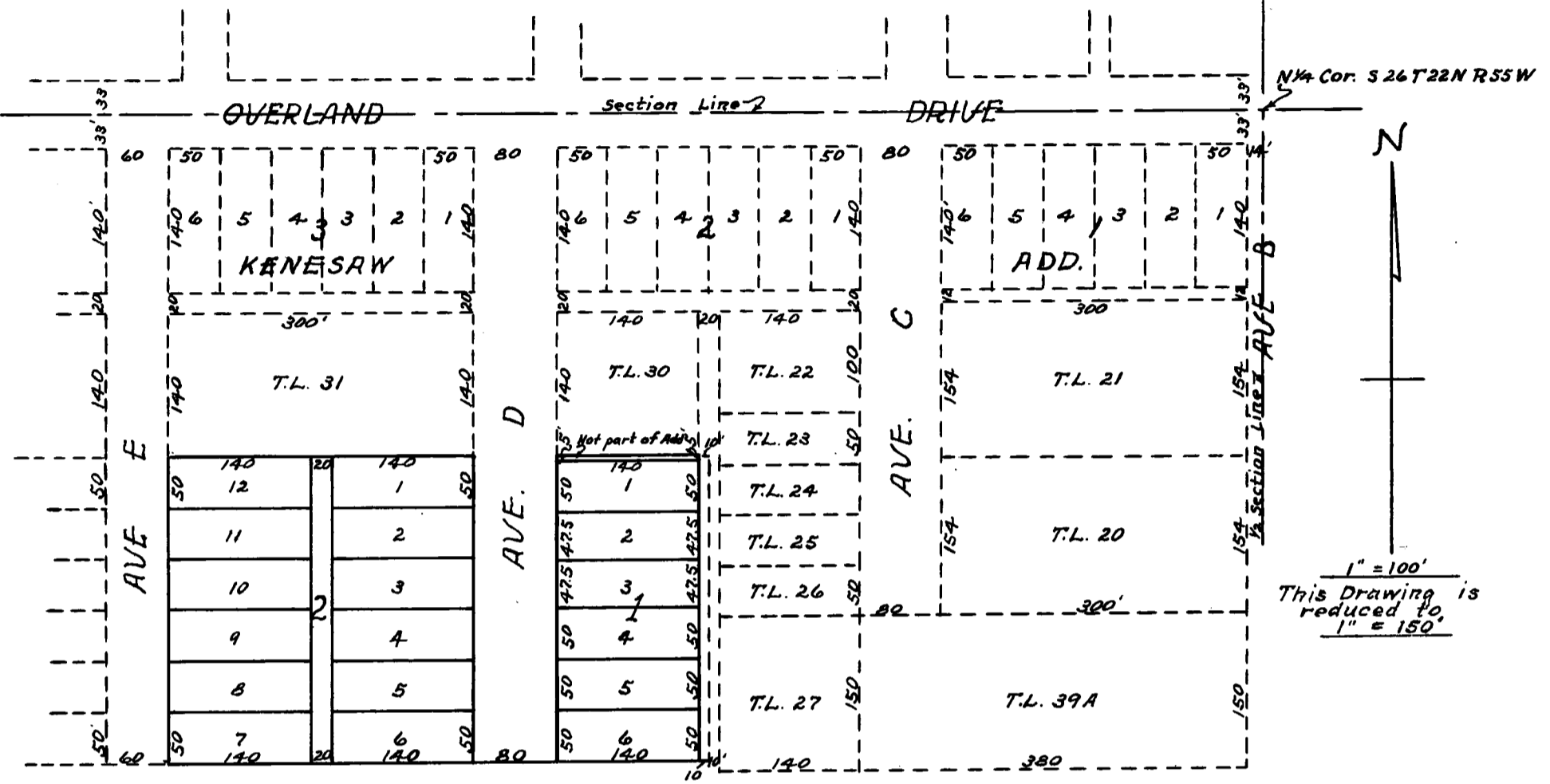

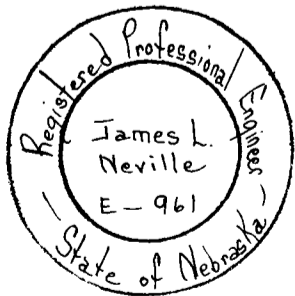
## FRANK ADDITION TO THE CITY OF SCOTTSBLUFF
