

I certify that on the 5th day of June 1951, I surveyed Fenning First Addition to the City Sering, Nebraska, located in Tax Lot 524 in the Northwest Quarter (NW2), Section Two (2), Township 21, North, Range West of the 6th P.M., more fully described as follows:

Beginning at a point located ICC feet south and 53.9 feet West of the Northwest Corner of Sandberg Addition to the City of Jering, Scotts Bluff County, Nebrasia; thence West 127.6 feet to the East line of Reeder Addition to the City of Jering, themce South along the East line of Reeder Addition a distance of 300 feet to the North line of Sands Add. to Jering; thence East 127 feet to the West line of 16th Street of said City; thence North along the West line of East Street extended a distance of 300 feet to the point of beginning.
