I certify that on the 14 day of October, 1951, I surveyed Masek's addition to the City of Gering, Nebraska, located in the Koenig Tracts, formerly Tracts No. 24, 25, and 26, Koenig Tracts, being part of SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 2, Township 21 North, Range 55 West of the 6th P.M., more fully described as follows:

Beginning at a point 80 feet west of the Northwest corner of Lot 4, Davies Addition to the City of Gering, Scotts Bluff County, Nebraska, thence west as a continuation of the north line of Davies Addition, 437.75 feet, thence south 317 feet, thence east 438.95 feet, thence north 317 feet to the point of beginning.

This plat is a true delineation of said survey drawn to a scale of one inch equals one hundred feet. The width of the alley and the dimensions of the lots are indicated on the plat in feet and decimals, and each lot bears its own number. A steel stake has been driven at each corner of each lot.



