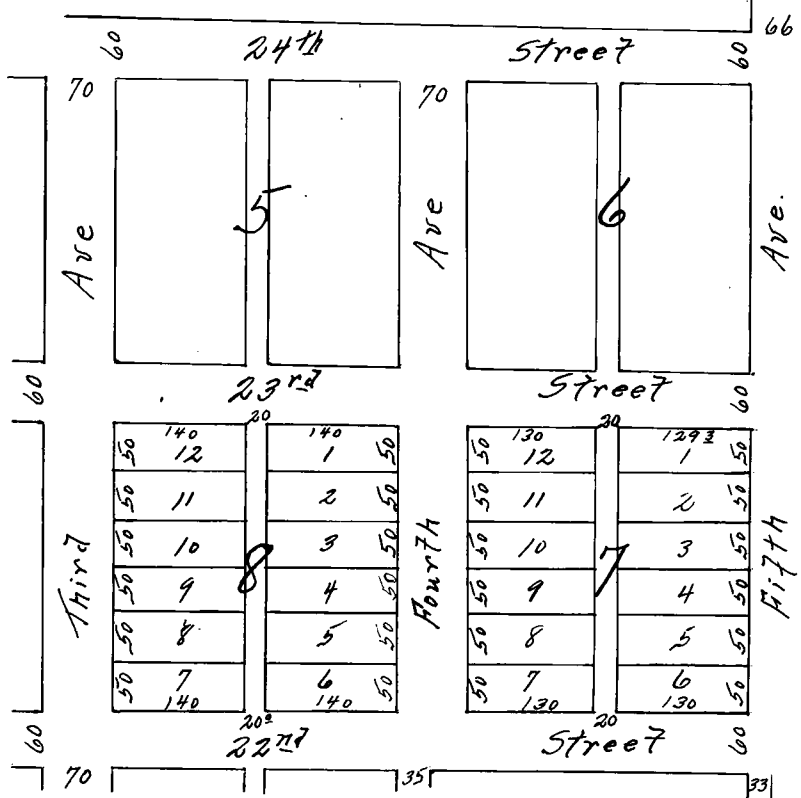

I hereby certify that on the 12th day of September I surveyed Blocks 7 & 8 of Bungalow Addition to Scottsbluff, situated on a part of Sec 23, Twp 22 N. of Range 55 W. of the 6th P.M., described as follows: Beginning at a point 33 West of a point on the East line of Sec 23, 692.8 feet North of the East Quarter Cor. of said Sec. 23, thence West 650 feet, thence North 360 feet, thence East 649.3 feet, thence South on a line parallel with the East line of Sec 23 a distance of 360 feet to the point of beginning; that the above plat is a correct delineation of said survey drawn to a scale of 200 feet to an inch. 1"xl $\frac{1}{2}$ " Fir stakes are driven well into the ground at front corners of each lot. The width of streets and alleys, and the dimensions of the lots are indicated on the plat in feet and decimals. Each lot and block bears it's own number.
