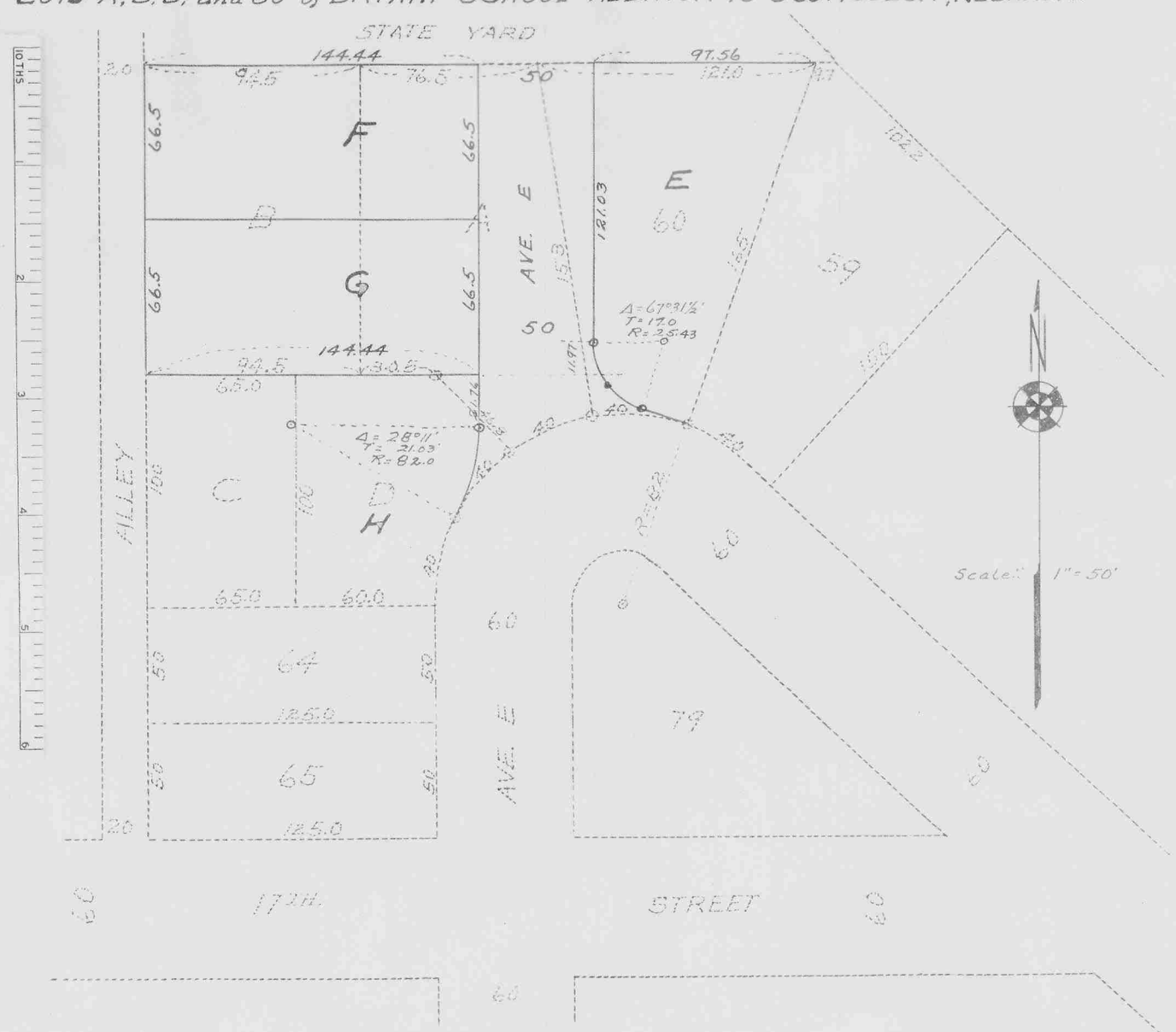

REPLAT OF LOTS A, B, D, and 60 of BRYANT SCHOOL ADDITION TO SCOTTSBLUFF, NEBRASKA



SURVEYOR'S CERTIFICATE

THIS IS TO CERTIFY that on the 3<sup>rd</sup> day of Aug., 1955, I surveyed the replat of LOTS A, B, D, and 60, of BRYANT SCHOOL ADDITION TO SCOTTSBLUFF, NEBRASKA, designating the re-platted area as LOTS E, F, G, and H, and Avenue E, and that the result of said survey is correctly shown on the above plat drawn to a scale of 50 feet to the inch. The letters, numbers, boundaries, and dimensions, of former lots, are shown on the plat by dotted lines, letters, and figures, while those of the replatted lots are shown by solid letters and figures. Each lot bears its own letter, and all dimensions are in feet and decimals. Iron rods are driven nearly flush with the ground at lot corners and points of curvature.
