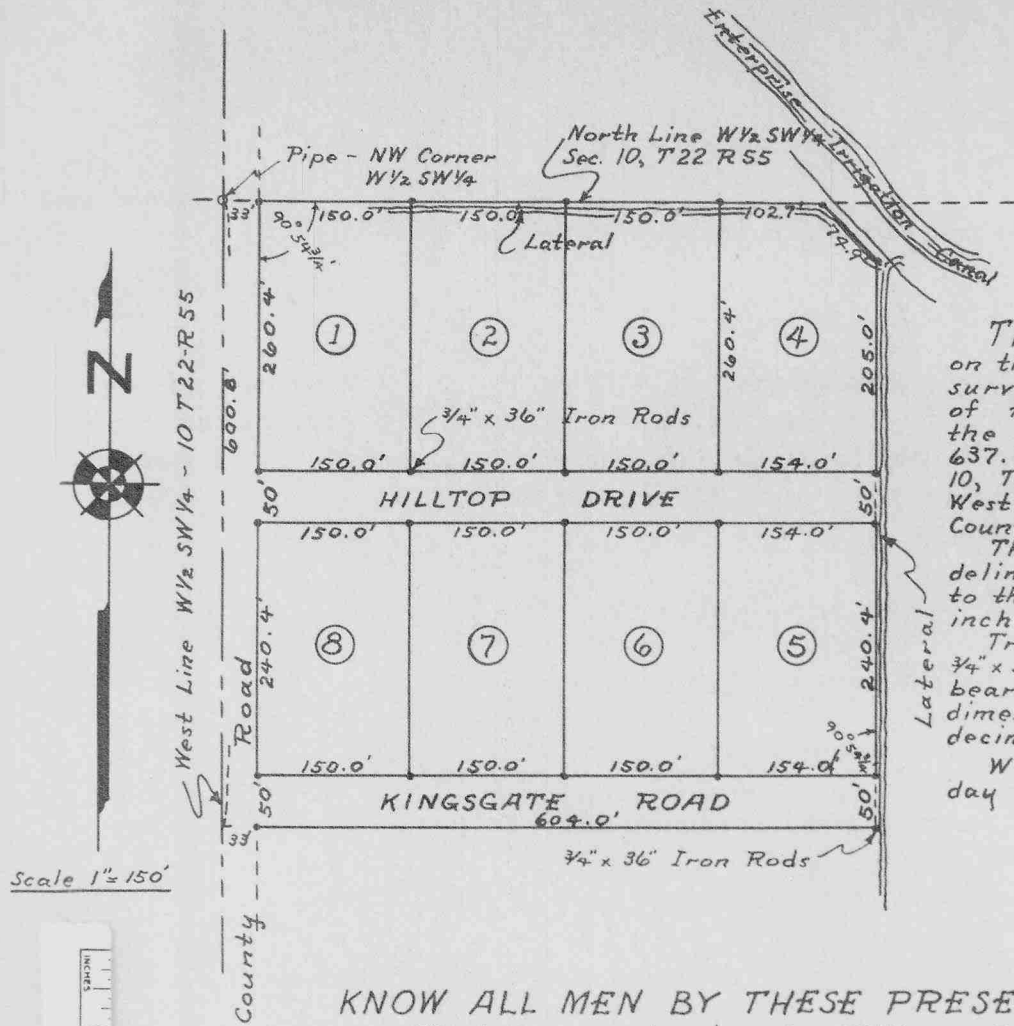


# FIRST CORNETT HEIGHTS



THIS IS TO CERTIFY :- That on the 29<sup>th</sup> day of March, 1955, a survey was made under my direction of FIRST CORNETT HEIGHTS, on the North 600.8 feet of the West 637.0 feet of the W 1/2 SW 1/4 Section 10, Township 22 North, Range 55 West of the 6<sup>th</sup> P.M.
