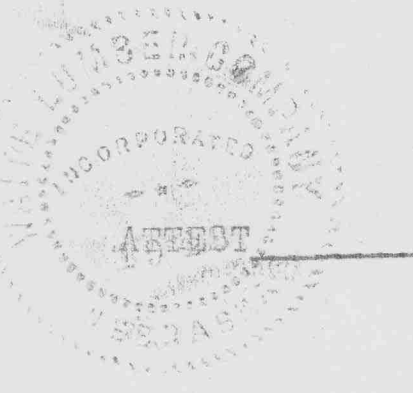

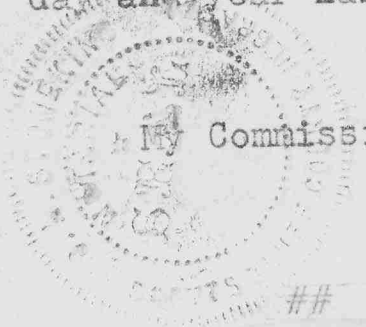

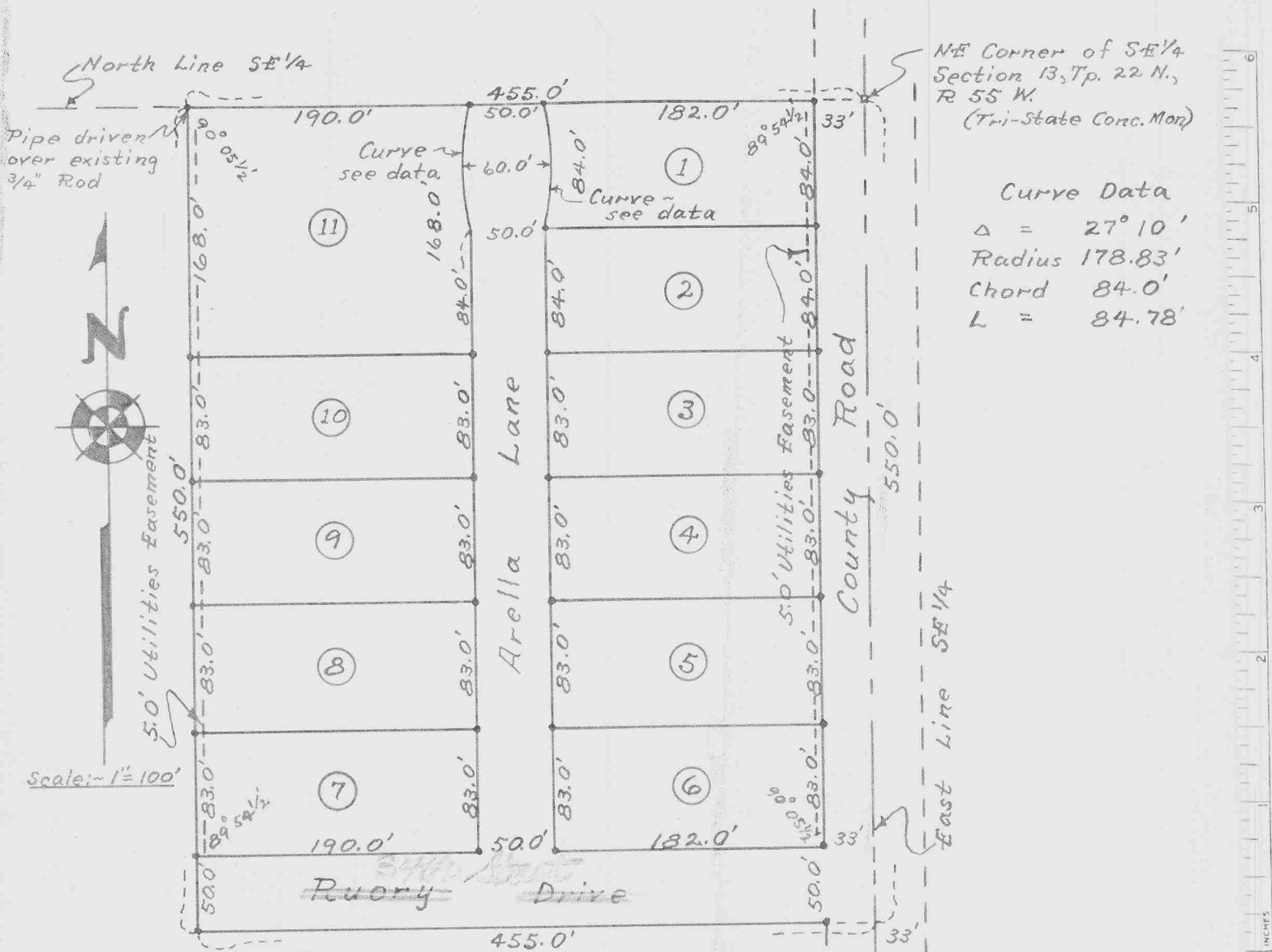

# SECOND REPLAT OF OLSON SKYLINE



## SURVEYOR'S CERTIFICATE

I, W.E. Keefover, a competent surveyor, in Scotts Bluff County Nebraska, hereby certify that I have accurately Second Replat of Olson Skyline, which is a subdivision of the North 550.0 feet of the East 455.0 feet of the NE 1/4 SE 1/4, Section Thirteen (13), Township Twenty-two (22) North, Range Fifty-five (55) West of the 6th P. M. Scotts Bluff County, Nebraska.

This plat is a correct delineation of said survey, drawn to the scale of 100 feet to the inch. Front and rear corners of each lot are marked with 1" Galvanized Pipe approximately 36" long (pipes at outlining corners approximately 60" long) driven nearly flush with the ground, except that markers on the west line of platted area, south of and including the northwest corner of Lot 9, are driven about 14" below the ground surface.

Each lot bears its own number, and dimensions are in feet and decimals.

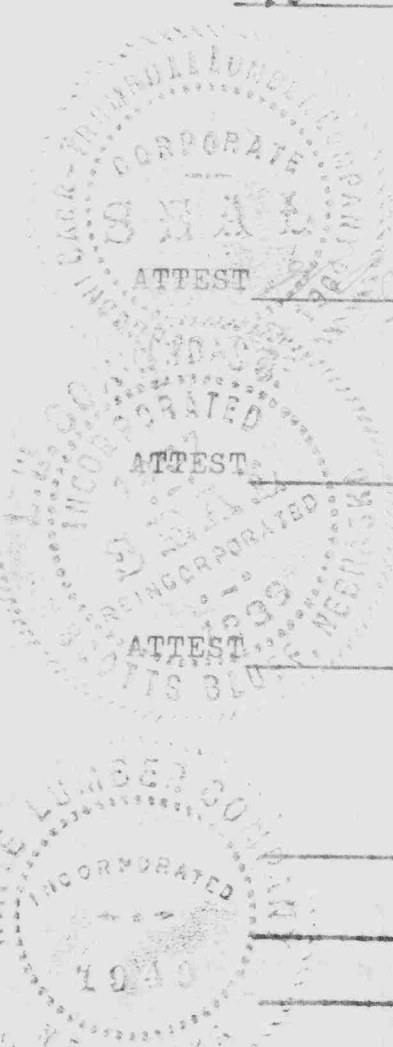
