Scotts Bluff County Nebraska, also referred to as West 20th Street and described as follows:

Beginning at East Quarter corner of said Section 22, thence Westerly to the North line of the Southeast Quarter of said section a distance of 1317.9 feet to the Northwest Corner of the East half of said SE Quarter, thence South along the West Line of the East half of the Southeast Quarter of said section a distance of 75.8 feet, thence Easterly a distance of 984.9 feet to a point 62.3 feet South of the North Line of the Southeast Quarter of said Section, thence Easterly and parallel to the East line of said Section a distance of 16.3 feet, thence Easterly and parallel to the North Line of the Southeast Quarter of said Section a distance of 333 feet to a point on the East Line of said Section, thence Northerly along the East Line of said Section a distance of 66 feet to the point of beginning;

said Section a distance of 333 feet to the point of beginning; as shown on the adjoining plat; and surveyors certificate does hereby dedicate said Tract to the use and benefit of the public and does hereby annex and make said real estate so shown on said plat, a part of the City of Scottsbluff, Scotts Bluff County, Nebraska.
