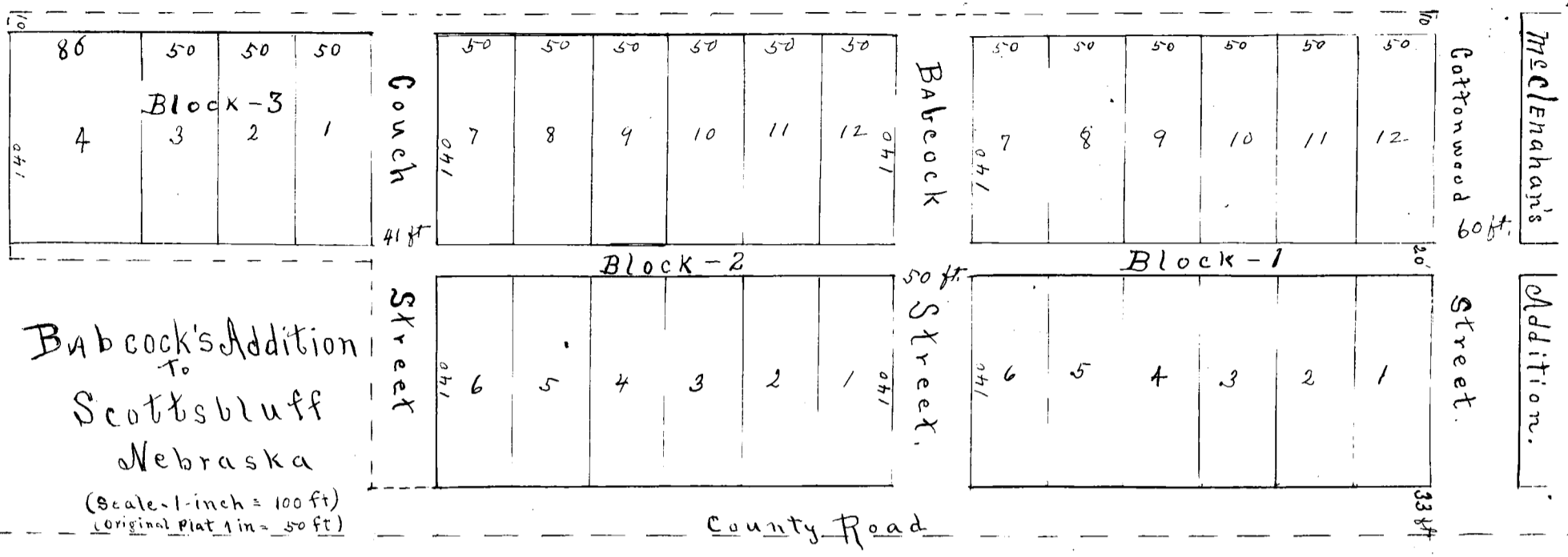


# DEED RECORD.

I hereby certify that I have surveyed BARCOCK'S ADDITION to Scottsbluff, Scotts Bluff County, Nebraska, situated on a part of the Southwest Quarter of Section Twenty-three (23), Township Twenty two (22) North, Range (55) West, in Scotts Bluff County, Nebraska; situated and bounded as follows - -

Beginning at a point Three hundred ninety-three (393) feet west of the southeast corner of the southwest quarter of said section running thence west six hundred ninety-one (691) feet; thence north One hundred eighty-three (183) feet; thence west Two hundred thirty-six (236) feet; thence north One hundred sixty (160) feet; thence east parallel with the south line of said quarter section nine hundred twenty seven (927) feet; thence south Three hundred forty-three (343) feet to the point of beginning. Said Addition being clearly shown by the plat hereto attached, which is a correct delineation of said survey drawn to a scale of Fifty feet (50) feet to an inch.

The streets and alleys are laid out parallel with and at right angle to the south line of said southwest quarter section. The width of the streets and alleys and dimensions of lots are indicated in feet and decimals by figures on the plat, each lot and block bears its own number.
