
## DEED RECORD.



I hereby certify that on the 13th day of Dec. 1899 I surveyed the town of Morrill, situated on the central part of the  $S_2^{\frac{1}{2}}$  of  $NW_4^{\frac{1}{4}}$  and the  $SW_4^{\frac{1}{4}}$  of Sec. 15 T. 23 N. R 57 W. which is clearly shown by the foregoing plat, which is a correct delineation of said survey, drawn to a scale of 180 feet to an inch. The streets and alleys are laid out parallel with, and at right angles to the W. line of said Sec. 15 except along the R.R. Burr oak stakes are driven well into the ground, at the front corners of each lot, and stones are planted low down in the ground at the places indicated. The width of streets and alleys and dimensions of lots and other distances are indicated in feet and decimals by red figures on the plat. Each lot and block bears its own number.
