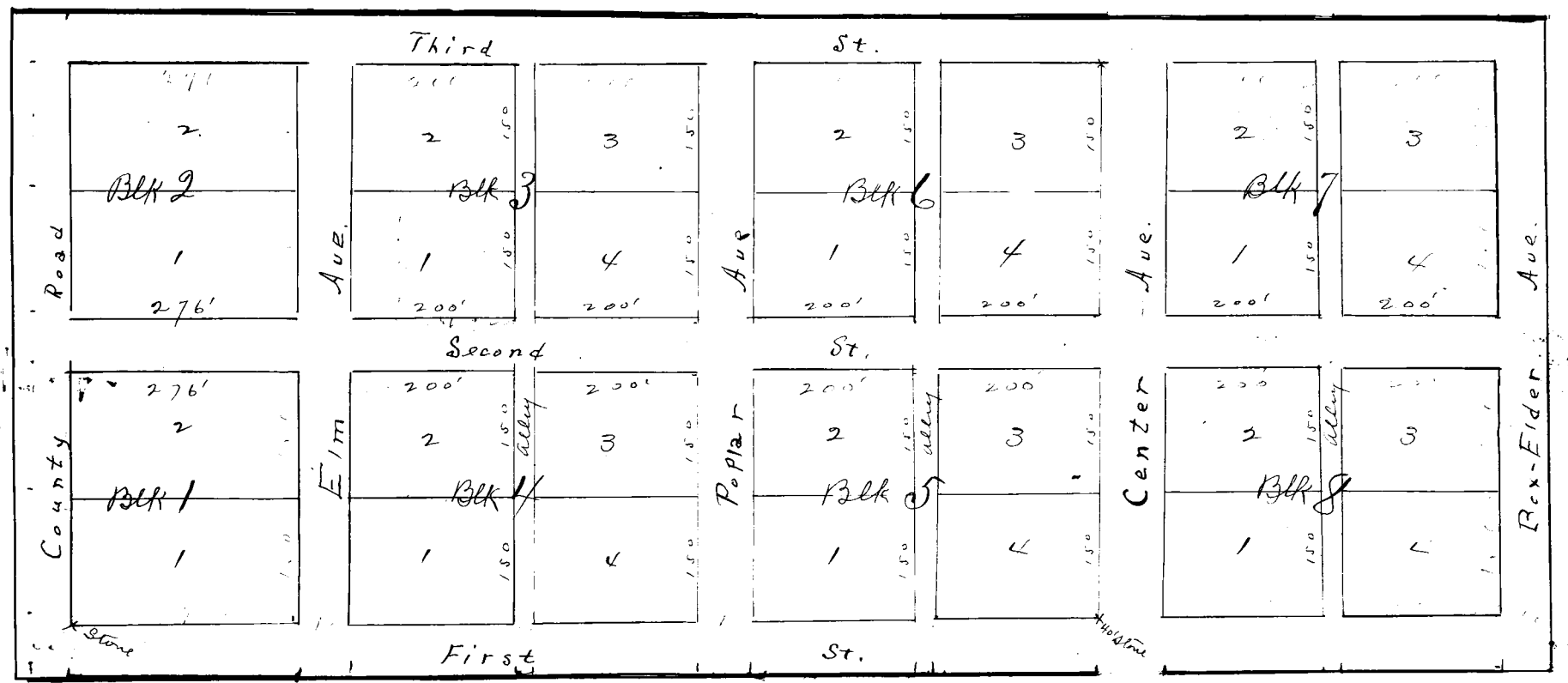

I hereby certify that on the 6th day of April 1906 I surveyed Logan's Addition to the town of Mitchell, Nebraska, said Addition is represented by the above plat and is a part of the SW $\frac{1}{4}$ of Section 22 Tp. 23 N. R. 56 W. more particularly described as follows: Beginning at a point 630 feet North and 33 feet East of the corner of Sections 21, 22, & 28, Tp. 23 N. R. 56 W. Thence East (Var. 15° 15') 1796 feet; Thence North (Var. 15° 20') 780 ft; Thence West (Var. 15° 15') 1796 ft; Thence South (Var. 15° 20') 780 ft; to the place of beginning containing 32.159 acres. The above plat is a correct delineation of said survey drawn to a scale of 160 ft. to an inch. The streets and alleys are laid out parallel with and at right angles to the Section line between Sections 22 & 27 Tp. 23 R/ 56, and Center Avenue, in width and direction is a continuation of center avenue in the original town of Mitchell. Pine stakes are driven well into the ground at the front corners of each lot and stones planted 1 $\frac{1}{2}$ feet deep in the ground at the places indicated. The width of streets, avenues and alleys and the deminstitutions of the lots and other distances are as indicated in figures on the plat. Each lot and block bears its own number.

KNOW ALL MEN BY THESE PRESENTS:

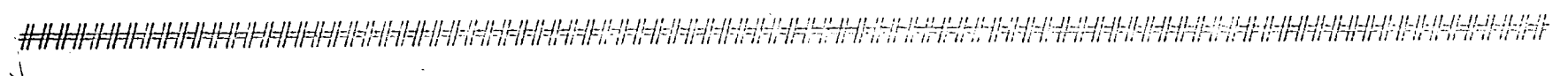
