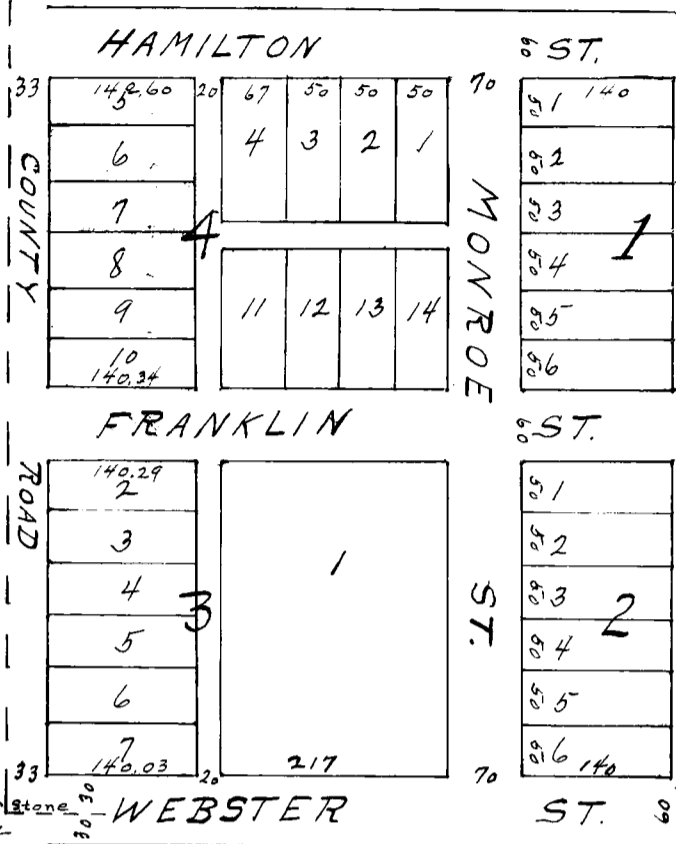

I hereby certify that in the month of April 1909 I surveyed PARK ADDITION TO MORRILL, situated on a part of the West half of Sec. 15, T. 23, N. R. 57 W. of the 6th P.M. as shown by the foregoing plat, which is a correct delineation of said survey drawn to a scale of 180 feet to an inch. All.

East and West Streets are extensions of E. and W. Streets of same name in the Original Town and First Addition, Monroe Street is parallel with Adams Ave. of the Original town and County Road is parallel with the Section Line. Oak stakes are driven well into the ground at the front corners of each lot, stones are planted

low in the ground at the places indicated.

The width of streets and alleys and demensions of lots are indicated in feet and decimals by red figures on the plat. Each lot and block bears its own number.
